**PUBLIC PATH DIVERSION ORDER 2022.** 

The above named order made on 1<sup>st</sup> April 2022 by the Shropshire Council ("the Council") under section 119 of the Highways Act 1980 and section 53A(2) of the Wildlife and Countryside Act 1981, will divert

The full width of that part of Footpath 5 from point A on the Order Map (SO 2955 8675) running along a grass and stone access track in a general north-north-easterly direction for approximately 88m. From there the footpath passes through a field gate and turns to run in a general east-north-easterly direction along a sealed surface for approximately 40m to meet another field gate. It then continues in the same general east-north-easterly direction, along a grass surface, for approximately 49m to meet a pedestrian wicket gate and the continuation of Footpath 5 at point B on the Order Map (SO 2969 8685) **onto a line** from point A on the Order Map (SO 2955 8675) running in a general north easterly direction on a natural grass surface for approximately 82m to a field gate. From there it continues in the same general north easterly direction along a natural grass surface for approximately 88m to meet point B on the Order Map (SO 2969 8685). A total distance of approximately 177m and a width of 2m throughout.
