





# Introduction

---

**This directory has been produced to outline the support available to children and young people in Shropshire who are victims of, or at risk of Child Exploitation - as well as their families and professionals who support them. Child Exploitation is a complex issue, in which there are sometimes other push factors in the young person's life, so information about other services have also been provided.**

## What is Exploitation?

Exploitation is a form of abuse, it occurs where an individual or group takes advantage of an imbalance of power to coerce, manipulate or deceive a child, young person or adult (including those with care and support needs) into: any activity that results in financial or other advantage for the perpetrator or facilitator. Activity includes arranging or facilitating the involvement or travel (trafficking) of a child, young person or adult (including those with care and support needs). Specific types of Exploitation include:

- Modern Slavery (including human trafficking)
- Sexual Exploitation
- Criminal Exploitation
- Financial Exploitation
- Any other Exploitation that enables benefits of any kind (eg. removal of organs, forced marriage, illegal adoption)

The victim may still be exploited even if the activities that they are engaging in appear consensual. Multiple types of Exploitation can occur alongside or as part of other forms of abuse.

## The role of the local authority

This directory has been produced by the TREES (Together Reducing & Ending Exploitation in Shropshire) Team within Shropshire Children's Services. The team's aims are to:

- Support parents and carers of children perceived to be at risk of CE - as it is recognised that the risks to children and young people at risk of exploitation are usually out in the community, rather than within the family home. This is what is known as 'Contextual Safeguarding'
- Discuss all referrals via bi-weekly multi-agency triage meetings - these referrals do not always result in social care involvement, in many cases children are referred to another service such as substance misuse support or diversionary activities with the aim of reducing the risk of exploitation.
- Work with other agencies to raise awareness of CE within schools and local communities.
- Support Social Workers and Early Help workers who are already allocated to open children where exploitation concerns have arisen.

# Reporting Concerns

---

**Before seeking support from any of the services provided within this Directory, please ensure that you call 999 if anyone is at risk of immediate harm.**

## **Report a non-urgent crime/incident or intelligence to the police:**

The ways in which children are exploited can amount to criminal behaviour by those who are exploiting them and/or as a presenting behaviour of a child who is being exploited.

There may also be behaviour that you witness in communities that cause you to be concerned that unknown children are being exploited (such as activity around addresses or locations).

If you have information about anti-social or criminal activity or behaviour (even where you do not know who is at risk or of concern) which indicates that child exploitation may be occurring and you **do not have information about specific children**, please ensure you pass this information to West Mercia Police as soon as possible to enable them to prevent and detect crime ([s115 Crime and Disorder Act 1998](#)). You can submit this information in the following ways:

- If you are a professional, email the information directly to the West Mercia Police CE Team in Shropshire: [CETeamShropshire@westmercia.police.uk](mailto:CETeamShropshire@westmercia.police.uk) (this inbox is monitored weekdays 8am - 4pm)
- Report under the [“Tell Us About”](#) section on the [West Mercia Police website](#) or phone 101.
- Report anonymously to [Crimestoppers](#) online at [www.crimestoppers-uk.org](http://www.crimestoppers-uk.org) or by calling 0800 555111.
- Where you think there is an immediate risk to a person or you witness a crime taking place, phone 999 (or dial 55 if you are unable to talk).

**Please note:** Where you have child specific information which suggests that a child is at risk of or experiencing harm as a result of exploitation, you must complete a CE Risk Assessment **and** pass information related to criminal activity or behaviour posing a risk to West Mercia Police.

Children, their families and/or other members of the community may be worried about sharing information about crime with the police, but are encouraged to report concerns anonymously via [Crimestoppers](#). # A-Z Glossary

## Terms you may hear in relation to Exploitation

**CAWN** - Child Abduction Warning Notice. Preventative tool issued to adults by police, which alert the respondent to the fact the authorities are aware of their involvement with a particular child. This is used as a disruption option to try and discourage the adult from associating with the child. These can only be issued to an adult, when the child is either under the age of 16 and parents provide their consent, or if the child is in local authority care.

**CCE** - Child Criminal Exploitation. A method where a perpetrator exploits a child for their own criminal gain.

**CIN / Child in Need** - A CIN is anyone under the age of 18 with a disability, or who requires support from their local authority to stay safe or maintain a reasonable standard or health or development. A CIN plan is put in place by social workers, medical professionals and parents to ensure the child's needs are met. It can only be put in place with parents consent.

**CLA** - Also sometimes referred to as LAC, but CLA is the preferable term. This refers to a Child Looked After – a child in the care of the local authority (residing within a residential placement, foster home or supported living placement) Refers to anyone up to the age of 18. Shortly before the child's 18<sup>th</sup> birthday, they are transferred to the Leaving Care team, who will oversee their transition from a CLA to adulthood.

**County Lines** - A system where gangs and Organised Crime Groups exploit children to sell drugs. Often these children are forced to travel across counties, and they use dedicated mobile phone 'lines' to supply drugs.

**Contextual Safeguarding** - Looking at the context of the relationships and risks surrounding a young person – who they engage with throughout their life, including their local community. Contextual safeguarding suggests that the risks are in the community, rather than within the home.

**CP / Child Protection** - Child Protection. This is the next plan up from a CIN status, which is drawn up by social workers. It sets out how the child should be kept safe and what support is needed. Consent from parents is not required for this, as it is a legal requirement.

**CSE** - Child Sexual Exploitation. A method where a perpetrator exploits a child for their own sexual gain.

**Cuckooing** - A crime which involves drug dealers taking over the home of a vulnerable person to use it as a base for drug dealing.

**EH / Early Help** - Early Help – A Shropshire Council service available to all young people and families, as soon as a problem emerges. It can be required at any stage in a child's life, from pre-birth to adulthood, and applies to any problem or need that the family can't deal with alone. The next step up from Early Help is social care.

# A-Z Glossary

## Terms you may hear in relation to Exploitation

**FGM** - Female Genital Mutilation. This ritual originates in Africa but also takes place in some Eastern European countries, and illegally in this country, to young girls and women from those backgrounds. It is linked purely to the country they originate from, rather than religion. Girls can be subjected to it at any age between 6 days old to adulthood. It can lead to death, or severe health complications after the procedure, including later on in life.

**Hazing** - Forced dares and initiations amongst groups of children and teenagers, influenced by gang culture and American fraternities.

**MAPPA** - Multi-Agency Public Protection Arrangements. This is the process in which police and other agencies work together to manage the risks posed by violent and sexual offenders living in the community in order to protect the public.

**MARAC** - Multi-Agency Risk Assessment Conference. This is the process in which multi-agency representatives discuss the safety, health & wellbeing of people experiencing domestic abuse & violence, & provide a safety plan for them and their children.

**NRM** - NRM referrals are made to the government's SCA (Single Competent Authority) when there is reason to believe that a child or adult is being trafficked (moved around) for the purposes of criminal activity. This can apply to cases of both CCE and CSE. Consent is not needed to gain an NRM for a child, but they need to consent once they turn 18, if keep the NRM in place. There are a number of benefits of an NRM – it aids prosecution of perpetrators without the need of a victim statement, and it offers a Section 45 statutory defence which assists in decriminalising. So if the young person is arrested, it informs the police that the child is a victim and may have been compelled to commit crimes under duress.

**OLA** - Other Local Authority. Refers to a child placed in Shropshire by another authority.

**Panel** - Monthly multi-agency meeting facilitated by the Compass Exploitation Team, to discuss the current picture of CE in Shropshire, and examples of good practice.

**Peer-on-peer abuse** - Recognised as a new form of abuse. This can consist of bullying, cyber bullying, sexting, teenage relationship abuse, and hazing.

**PWITS** - Possession With Intent To Supply – this criminal offence is often referred to using this acronym.



# A-Z Glossary

## Terms you may hear in relation to Exploitation

**RHI** - Return Home Interview following a Missing episode, conducted by the child's allocated social worker.

**Section 17** - Section of the Children's Act which states that it is the general duty of every local authority to safeguard and promote the welfare of children within the area who are in need. If it's decided that the threshold for Section 17 has been met, then a Social Work Assessment will take place. To judge whether the threshold for a Section 17 has been met, a social worker asks: Will the child's health and development be impaired without the provision of services?

**Section 47** - An investigation which takes place within Children's Services, which often takes place jointly with the police. A strategy meeting is held within Children's Services to determine whether the threshold for a Section 47 investigation has been met. This is met when there is reasonable cause to suspect that a child is suffering, or likely to suffer from harm in future. The enquiry involves an assessment of the child's needs and the ability of those caring for the child to meet them. The aim is to decide whether any action should be taken to safeguard the child. The assessment will involve interviews with the child, their parents, school and medical professionals.

**Smarter** - Smarter Screening Tool – the format in which a child is referred to the We Are With You service. It assesses which substances a child uses, and how this impacts their life. The tool can be found at the Early Help website, under the section titled 'Substance misuse toolkit' <https://shropshire.gov.uk/early-help/practitioners/early-help-tools>

**SWA / Social Work Assessment** - The initial assessment completed when a child is referred into social care. For this to take place, one of more of the child's parents must provide consent.

**Triage** - Bi-weekly multi-agency triage meetings facilitated by the Compass Exploitation Team, to consider the most appropriate next steps for a child referred due to CE concerns.
