**THE SHROPSHIRE COUNCIL (FOOTPATHS 1 (PART), PARISH OF LUDFORD)
PUBLIC PATH DIVERSION ORDER 2022**

This Order is made by the Shropshire Council (“the Council”) under section 119 of the Highways Act 1980 (“the 1980 Act”) because it appears to the Council that in the interests of the landowner of the land crossed by the footpath described in paragraph 1 of this order it is expedient that the line of the way should be diverted.

This Order is also made under section 53A (2) of the Wildlife Countryside Act 1981 (“the 1981 Act”) because it appears to the authority that the Shropshire definitive map and statement require modification in consequence of the occurrence of an event specified in section 53 (3)(a)(i) of the 1981 Act, namely, the diversion (as authorised by this Order) of a highway shown or required to be shown in the map and statement.

BY THIS ORDER:

1. The public right of way over the land situated off Foldgate Lane, and shown by a bold continuous line on the map contained in this Order and described in Part 1 of the Schedule to this Order shall be stopped up on the date that the Council certifies that works have been carried out to bring the site of the new Footpath described in Part 2 of the Schedule to this Order into a fit condition for use by the public and thereupon the Shropshire definitive map shall be modified by deleting from it the public right of way to be stopped up.

2. Notwithstanding paragraph 1 of this Order statutory undertakers shall have the following rights over the land referred to in paragraph 1 above, namely: where immediately before the date on which the footpath is diverted there is apparatus under, in, on, over, along or across it belonging to statutory undertakers for the purpose of carrying on their undertaking, the undertakers shall continue to have the same right in respect of the apparatus as they then had.

3. There shall on the date of confirmation of this Order be a public footpath over the land situated off Foldgate Lane, described in Part 2 of the Schedule and shown by bold broken lines on the map contained in this Order and thereupon the Shropshire definitive map shall be modified by adding that path to it.

3A. The Shropshire definitive statement shall be modified as described in Part 4 of the Schedule to this order.

4. The rights conferred on the public under this Order shall be subject to the limitations and conditions set out in Part 3 of the Schedule.

SCHEDULE

PART I

Description of site of existing path or way

The full width of that part of Footpath 1 from Steventon Road at point A on the Order Map (SO 5230 7361), running in a general ESE direction on a natural surface to cross the railway line then in a general SSE direction on a natural surface to point B on the Order Map (SO 5238 7356), a total distance of approximately 256 metres.

PART 2

Description of site of new path or way

A Footpath to be created where it leaves the Definitive line of FP 1 at point B on the Order Map (SO 5236 7356) running in a general NNE, easterly then general north easterly direction on a 2 metre wide surfaced path to point C on the Order Map (SO 5260 7374). From here the footpath will follow the highway pavement in a general east then northerly direction to point D on the Order Map (SO 5260 7383) then in a general northerly, north westerly then westerly direction on a 2 metre wide surfaced path to a pedestrian gate on Foldgate Lane at point E on the Order Map (SO 5235 7398). A total distance of approximately 849 metres with a width of 2 metres throughout its length.

Limitations and conditions

Pedestrian gate at GR SO 5235 7398 to BS 5709

PART 4

Modification of Definitive Statement

A Footpath to be created where it leaves the Definitive line of FP 1 at point B on the Order Map (SO 5236 7356) running in a general NNE, easterly then general north

easterly direction on a 2 metre wide surfaced path to point C on the Order Map (SO 5260 7374). From here the footpath will follow the highway pavement in a general east then northerly direction to point D on the Order Map (SO 5260 7383) then in a general northerly, north westerly then westerly direction on a 2 metre wide surfaced path to a pedestrian gate on Foldgate Lane at point E on the Order Map (SO 5235 7398). A total distance of approximately 849 metres with a width of 2 metres throughout its length.

There is no Shropshire definitive statement for the remainder of Footpath 1 in the Parish of Ludford.
