The full width of that part of Bridleway 277 running from point A on the order map GR 5151 9170 in a general NNW then north easterly direction over a yard area, through a gate on a natural surface to point B on the order map GR 5154 9175. A distance of approximately 88 metres **onto a line** leaving point A on the order map GR 5151 9170 running in a general easterly then north westerly direction on a natural surface to re-join the Definitive Line of BW 277 at point B on the order map GR 5154 9175. A distance of approximately 110 metres with a width of 3 metres throughout its length.
