The building lends itself to a variety of uses within this historic building in the heart of Shrewsbury.


# Description:

'Old St Chads' dates back to the 1100s and is a sandstone structure with four gothic windows and double height ceiling of 7.54m (24.73 ft). The building is teeming with history architecture and fenestration, the building retains some original features such as the dado paneling wrapped around the circumference of the room and original wooden door.

#### Situation:

Located on Belmont in the heart of Shrewsbury, off both the established High Street and the historic town square.


