Bishop's Castle Key Facts

Located in the southwest of Shropshire and is the largest area in size at over 52,000 hectares.

It is the most sparsely populated area in Shropshire, with a population of around 11,000 residents and a population density of 0.2 persons per hectare.

The population grew from 6,903 to 10,856 (2002 - 2020) a rise of 57.3%. There were over 1,300 births between 2001 and 2019 (2.5% of all live births in Shropshire during the same time period), with 50 births in 2019 (1.9% of all births across Shropshire).

Higher life expectancy for both males (81.0) and females (85.6), compared to Shropshire (80.5 and 84.1 respectively)

More people aged 65+ compared to Shropshire overall (2020):

- o 13.8% aged 0-15, lower than 16.3% in Shropshire
- o 55.5% of working age (16-64), lower than 58.7% in Shropshire
- o 30.7% aged 65+, higher than 25.0% in Shropshire
- Average age of residents is 49 years old, higher than Shropshire (45 years old)

Has the 2nd highest overall deprivation score out of all 18 place plan areas, behind Craven Arms.

Median gross household income is £31,849, below the Shropshire average of £32,808 and ranking 13th lowest out of the 18 place plan areas.

Majority of Bishop's Castle's residents registered at English GP practices (9,000+) are registered at Bishop's Castle Medical Practice (46%, July 2021). however, a significant percentage of patients are registered at practices in other place plan areas including Pontesbury Medical Practice (25%).

Health and Wellbeing Index Overview and Detailed Domains

The Health and Wellbeing Index (HWI) is our way to summarise the large amount of local and national data used for each place plan area (PPA). The data is placed into different themes to give an overall score for health and wellbeing for each PPA. The three overarching themes are Healthy People, Healthy Economy and Health Environment ("Healthies") and can be seen in the diagram below.

As more data is gathered in future such as school attainment levels, it will feed into these themes and the overall score for each plan each.

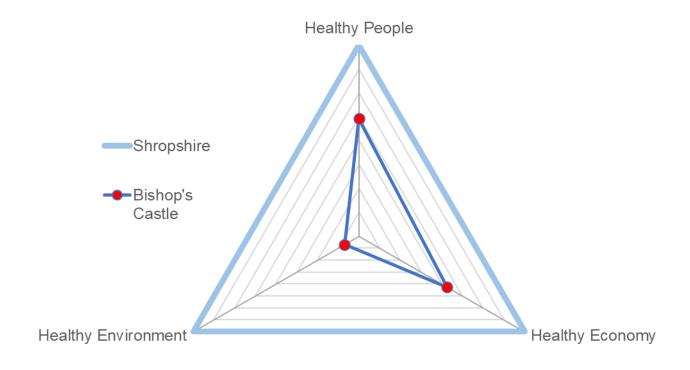

- Healthy Economy includes Equality, Economy, Work and Employment and Cost of Living Vulnerability.

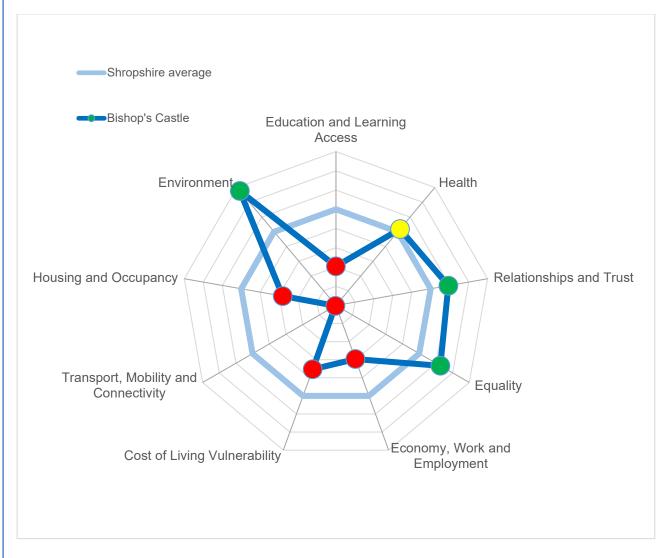

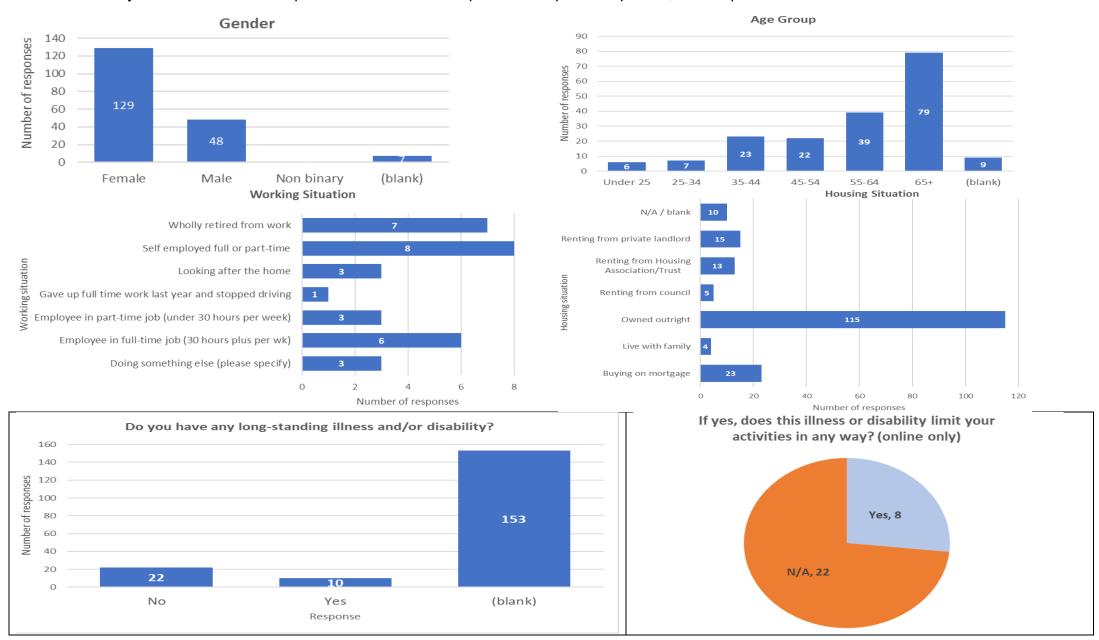

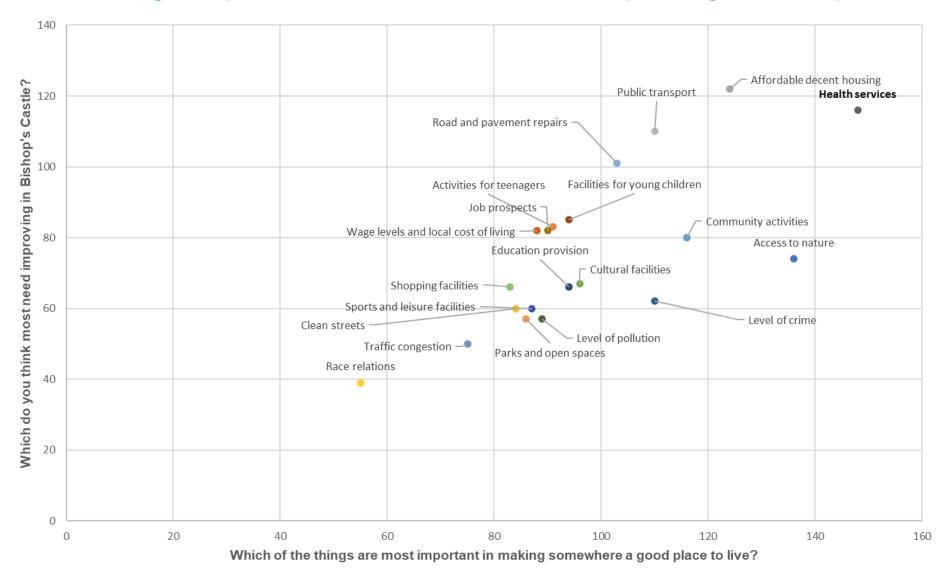

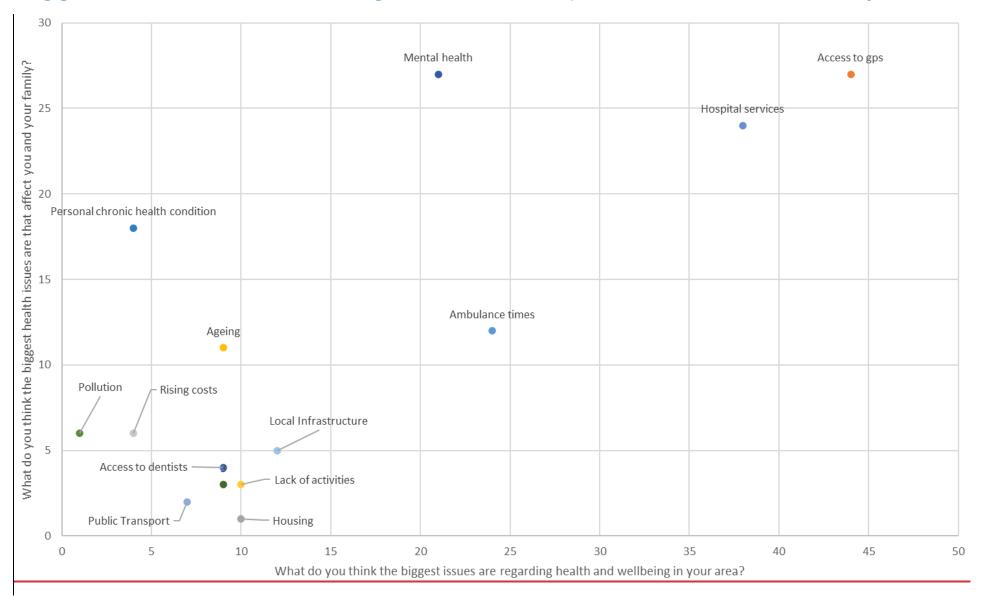

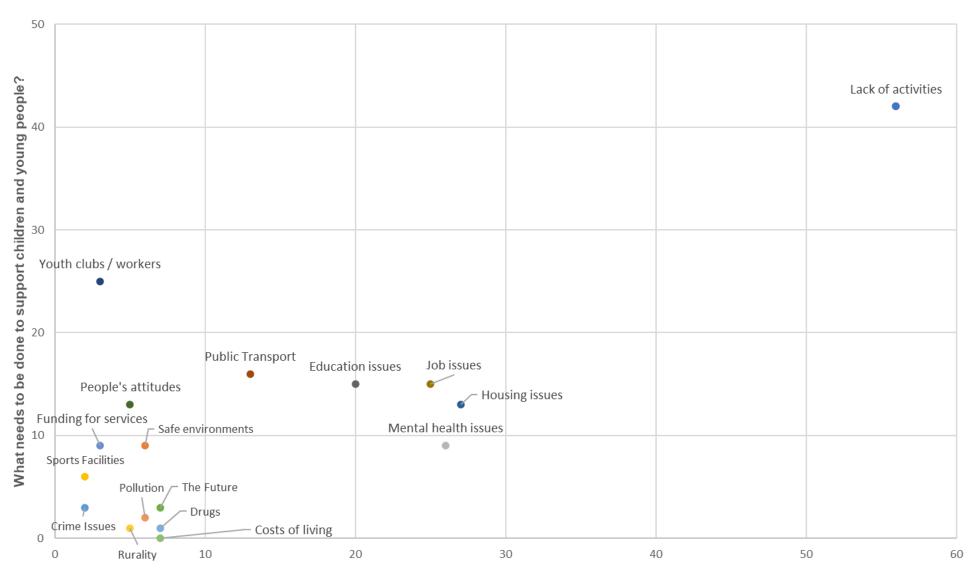
What makes a good place to live Vs What needs improving in Bishop's Castle

What do you think are the biggest issues facing children and young people?

Focus Theme 1 – Health and Access to Health Services

- Health Services was the most important theme for making an area a good place to live. It was also the
 second top theme for what can be improved. Improvements can focus on working with the community on
 how the wider determinants of health, such as housing, environment, and education also have a
 significant impact on improving health and wellbeing.
- Public Transport was ranked high for makes a good place to live and what needs improving.
- Access to GP services was the most frequent issue followed by accessing hospital services for both community and personal/family level needs.
- The closure of the local hospital and the long distance in order to get to the nearest hospital and ambulance times were also common issues.
- Mental health issues featured significantly in the biggest health and wellbeing issues.
- One of the biggest issues affecting young people was mental health issues.
- Ranked 6th best place plan area for health in Health and Wellbeing Index overview.

"Closure of local hospital due to staff shortages delays & access to hospital services in Shrewsbury distance from Bishops Castle to hospital services lack of local mental health services"

"Distance from services. Too many retirees moving into the area putting pressure on health services and housing for young people"

Focus Theme 2 – Housing and Cost of Living

- Rated 17th out of 18 PPA for "housing and occupancy" and "cost of living vulnerability" (page 6).
- 2nd highest (worst) deprivation score of the 18 PPA's in the index of multiple deprivation (IMD) domain around barriers to housing and services.
- It is both more expensive to buy a house and less affordable for local people due to average house sale price (£310,000) compared to gross household income (£31,849): 3rd highest median affordability ratio (9.7) and the 6th highest rank for lower quartile affordability ratio.
- Housing was identified as the 2nd most important issue affecting younger people, including additional comments of housing prices being too high for younger people to be able to buy or even rent in the area.
- At 29% of households are one person households the 4th highest percentage of the 18 place plan areas. Of these one person households 14.4% are aged 65 or over and is the 7th highest percentage of the 18 place plan areas.
- It has the highest percentage of households without central heating at 6% compared to 3.2% in Shropshire.
- 20.3% of households were fuel poor, the highest PPA in Shropshire and Shropshire overall was 12.3%.

"No "affordable" housing being built driving people out into the towns and cities when we don't want to."

"Cannot afford to live here"

"My four children are grown up and have left the area (and country) because work is very limited and housing too expensive."

Focus Theme 3 – Lack of Activities

- Activities for Teenagers was the 5th most selected theme for what most needs improving.
- Lack of activities and things to do was the overwhelming response for the biggest issue facing children and young people.
- Lack of out of school activities, youth clubs / youth workers, safe places to go and lack of support were frequently mentioned.
- Youth services were the most common area of focus on what needs to be done to support children and young people.
- Respondents also mentioned that boredom led to unsociable / criminal behaviour.
- Other concerns included lack of activities in their rural area, issues with accessing sport / leisure facilities and travelling long distances to access things.
- 66% of all respondents said they did not face challenges to being active in their daily life. However, for those who did face challenges they faced barriers including lack of local facilities or transport issues or the time it takes to get to local facilities.

Access to a space, just to meet and talk. Promotion of affordable, accessible activities. Education looking at a more child/young person approach rather than results driven. Lack of facilities and activities. There is nothing at all in our village and we are wholly reliant on schools for activities."

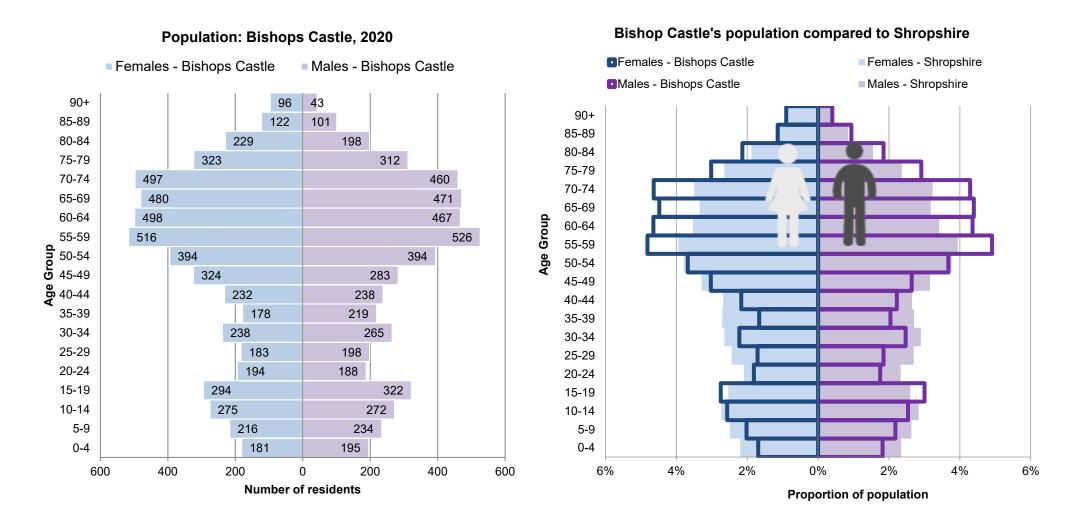
"Time as you often have to travel to Shrewsbury for decent facilities"

- Employment: includes employees plus the number of working owners. BRES therefore includes self-employed workers as long as they are registered for VAT or Pay-As-You-Earn (PAYE) schemes. Self-employed people not registered for these, along with HM Forces and Government Supported trainees are excluded.
