**THE SHROPSHIRE COUNCIL
(BRIDLEWAY ADDITIONS, PARISH OF WESTON-UNDER-REDCASTLE)
MODIFICATION ORDER 2017**

This Order is made by The Shropshire Council ("the Council") under section 53(2)(b) of the Wildlife and Countryside Act 1981 ("the Act") because it appears to the Council that the Shropshire Definitive Map and Statement require modification because in accordance with the provisions of Section 53(3)(c) the Council has discovered evidence which (when considered with all other relevant evidence available to them) shows -

- (i) that a right of way which is not shown on the map and statement subsists or is reasonably alleged to subsist over land in the area to which the map relates, being a right of way such that the land over which the right subsists is a public path, a restricted byway or, subject to section 54A, a byway open to all traffic

The Council hereby order that:-

1. For the purpose of this Order the relevant date is 1st May 2017.
2. The Shropshire Definitive Map and Statement shall be modified as described in Part I and Part II of the Schedule and shown on the maps attached to the Order.
3. This Order shall take effect on the date it is confirmed and may be cited as The Shropshire Council (Bridleway Additions, Parish of Weston-under-Redcastle) Modification Order 2017.

SCHEDULE

PART I

Modification of Definitive Map

Description of paths or ways to be added

A bridleway to be added from point A on the order map (SJ 5668 2769) where it leaves Restricted Byway 4, running in a general south westerly direction for a few metres, then turning to follow a general westerly direction along an enclosed track, with a width varying between 3 and 6 metres, continuing to run adjacent to the northern boundary of Weston Heath Coppice passing point C on the order map (SJ 5623 2771) and continuing to enter the woodland at SJ 5609 2772 from where the route becomes a woodland path with a width of 3 meters, running in a westerly direction for a short distance then turning to run in a general north westerly direction before curving round to run down a steep incline in a general south westerly direction to its junction with Restricted Byway 4 at point B on the order map (SJ 5568 2781); a total distance of approximately 1158 metres;

and

a bridleway to be added from point C on the order map (SJ 5623 2771), running in a general southerly followed by south westerly direction descending through Weston Heath Coppice, with a width of 3 metres, to its junction with Restricted byway 4 at point D on the order map (SJ5597 2736); a total distance of approximately 476 metres

PART II

Modification of Definitive Statement

A bridleway to be added from point A on the order map (SJ 5668 2769) where it leaves Restricted Byway 4, running in a general south westerly direction for a few metres, then turning to follow a general westerly direction along an enclosed track, with a width varying between 3 and 6 metres, continuing to run adjacent to the northern boundary of Weston Heath Coppice passing point C on the order map (SJ 5623 2771) and continuing to enter the woodland at SJ 5609 2772 from where the route becomes a woodland path with a width of 3 meters, running in a westerly direction for a short distance then turning to run in

a general north westerly direction before curving round to run down a steep incline in a general south westerly direction to its junction with Restricted Byway 4 at point B on the order map (SJ 5568 2781); a total distance of approximately 1158 metres;

and

a bridleway to be added from point C on the order map (SJ 5623 2771), running in a general southerly followed by south westerly direction descending through Weston Heath Coppice, with a width of 3 metres, to its junction with Restricted byway 4 at point D on the order map (SJ5597 2736); a total distance of approximately 476 metres
