Anna,

Thank you for the updated GTAA and LPA response to the Inspector.

The owner of the Warrant Road site is choosy about who he allows onto the site. He admits he is branching out into park homes that serve the non-travelling community as well as travellers. I notice that no households were interviewed at Warrant Road Site 2 (page 24 GTAA). The pitches here are not fully available and suitable for gypsy families and should not be counted in the figures.

If you don't get onto the Warrant Road site, and don't want a Council pitch, then there isn't much choice in Shropshire.

Shropshire Council first announced its intention to allocate sites for gypsies and traveller in 2010, but has never followed through by actually identifying any new sites in its Local Plan. Every planning application faces intense opposition and a battle to get permission. We need allocations to ensure the next generation can find a pitch and has a choice of suitable places. Not everyone wants a Council pitch.

In short, the Council needs to discount Warrant Road site 2 and allocate enough pitches to meet needs up to 2026 as the legislation requires.
