Main Modification reference - MM203: changes to policy S18.1(5) for Whitchurch and new text in explanatory paragraph 5.184, "In these circumstances the strategy recognises land to the West of the town within the by-pass as offering a potentially suitable broad location for housing there is available land adjoining the Whitchurch development boundary which offers potentially suitable broad locations for housing, and which is in keeping with the Whitchurch Town Plan".

The Main Modifications document states these changes are, "To clarify that MD3 determines the approach to the release of further land for windfall development where appropriate".

This Main Modification supports proposed modifications to policy MD3, and is necessary to overcome the unsoundness of the Plan in relation to its inadequate justification of proposed allocations and exclusion of other sites, such as WHIT008. This Modification is also necessary to address the lack of sufficient windfall in North East Shropshire, required to ensure that the Plan is positively prepared and effective. Furthermore, the Modification is essential to ensure that the NPPF's 'presumption in favour of sustainable development' is applied.

There is recent evidence that this Modification fails to achieve these objectives. The site at Liverpool Road (WHIT008) was refused on 3rd July 2015 after the officer's report carefully considered SAMDev Plan policies. Paragraph 6.1.4 of the officer's report states: "The Inspector's proposed modifications make no change to several highly significant areas of policy S18. Notably there are no changes proposed to the housing guideline for Whitchurch of 1,200 dwellings over the plan period; no change to the extent of the development boundary for the town; and, no change to the any of the proposed housing allocations. Importantly, and notwithstanding the representations made by the applicant in support of this site, the Inspector has chosen not to recommend the site for inclusion as a housing allocation. As such it is considered that significant weight can now be placed upon policy S18. Policy S18 does not allocate the application site for development and continues to place the site outside the development boundary. It is therefore considered that significant weight be given to policy Core Strategy CS5 given the site is located in the 'countryside' in policy terms, and that relevant policy constraints should apply."

The explanatory text to which MM203 refers is not mentioned in the officer's report in any way. Neither this explanatory text, nor the policy MD3 that it supports, had any bearing on the recent decision by the Council regarding a site in precisely the type of location that this modification is intended to influence.

It is apparent from the above officer's report and Shropshire Council's recent decision on the Liverpool Road site that the proposed modification is ineffective. Explanatory text is easily ignored (as demonstrated above) and therefore does not adequately address the soundness issues in the Plan. Consequently the Plan remains unsound.
