The Sam Dev Document makes no provision for housing in Trefonen. This is a major village which will inevitably require some housing in the medium to long term. This lack housing provision is not based on evidence but simply in response to local representation. It is unrealistic to think that a major settlement that has developed in recent years will not need to continue some expansion (at whatever rate) in the future.

The Document will be ineffective because inevitably there will at some time be a requirement to provide some housing in the village and granting permission will be contrary to the Council's adopted LDF. This will undermine the credibility of the Council's Planning Strategy for years to come.

No provision has been made for the supply of self build plots as required in the National Planning Policy Framework.

The Sam Dev Document makes only very limited provision for housing in Park Hall and only appears to support a site which has had planning permission for many, many years and has not been developed. The Council has no evidence that the site is deliverable as required by the National Planning Policy Framework.

The Council appears to have no real evidence as to the need or demand for housing in this area and has made no provision for the young people and families who have grown up here and wish to remain.

Park Hall is a popular and very sustainable location and the Document will be completely ineffective if it is not able to deliver a level of housing beyond that proposed.

The land allocation in Park Hall has ignored a significant brown field site (The Piggeries) that lends itself to development with housing. If The Piggeries is developed it will ensure a modest level of housing provision in a very sustainable location and at the same time improve the amenity of local residents by removing commercial activity with real potential for conflict.
