Would like much higher environmental Sustainability Code put in place, i.e Level 4 (SCL4) as a minimum for all new housing.

Housing Densities are also an issue. Not adverse to higher densities, if the flip side is fantastic open space and room for wildlife, but densities in the developments I've seen seem to favour the house builder only. PLOT SHREW016 is a case in point, housing should be restricted to allow both wildlife space (to the river) and public amenity (footpath/routes).

Finally, please reassure me that cycling and general route corridors are at the forefront of planning.

Perhaps these and the key public amenity space/wildlife areas should figure on the overall SAMDEV maps to better show the context of these proposed built areas?
