Allocation of site WEM003 will still mean that most of the additional commuter traffic will have to negotiate the narrow/congested streets in Wem Town Centre – notably the double-bend corner by Maund's garage and the junction by the Main church. Even with potential employment opportunities at site ELR031, the above will remain true. We would estimate 100 – 150 cars per direction, per day, which we argue is a significant increase in the daily 'rush hour' congestion. This will be unavoidable for any development to the W of the Town, unless of course there is major investment in infrastructure in the form of a bypass around the SW of the town. Already, at peak times, the junction of Lowe Hill Road with Ellesmere Road clocks 400 vehicle movements an hour.

Wem has approx. doubled in size in the last 30-40 years, raising questions about 'fair share' and infrastructure. Nevertheless, *if* 100 new dwellings *can* be justified in/near the town, they are being proposed on the wrong side of town – i.e. on the far side from access to Shrewsbury, Telford and the M54 where the vast majority of Wem's commuter traffic heads every day. A development on the SE of the town would circumvent most of the problems outlined
