The Parish Council has a major concern about access to the site from a busy Junction off the A49.

The area lacks the facilities and the minimum level of infrastructure development to accommodate and ensure the safety of users accessing the proposed mixed residential/employment site from the dangerous stretch of roadway along Sheet Road and the main A49 Trunk Road.

This area (on both sides of Sheet Road) scored poorly on the ecological element of the site assessments. Therefore the Parish Council strongly regrets the proposal to eradicate the mature hedge along the boundary of the site because of the road widening for access to the site. High quality environmental improvements should be included in the scheme in order to improve the area and ensure that this development enriches the landscape.

Every opportunity should be made to include footpaths and cycle ways towards LUD017 Rocks Green in order to improve connectivity and allow access to employment and other facilities	
The Parish Council have also been informed by Ludlow Town Council of their concerns the service infrastructure within Ludlow to support the additional houses and that these issues have not been addressed adequately in the preparation of the plan.	about

Ludford Parish Council strongly objects to the inclusion of employment land to the South of Sheet Road. This site was not included in earlier published SAMDev proposals.

In previous responses to the consultation documents the Parish Council has consistently requested that any development outside the Ludlow Town Council boundary should take place in the area between The Sheet and Rocks Green to the North and East of the Eco Park and that there should be no development to the South of Sheet Road and would therefore prevent unnecessary urban sprawl or ribbon development.

The proposals of ELR059 provide employment opportunities and there is sufficient remaining space for development of that site.

Access from either site to the A49 remains a major concern, the Parish Council have previously accepted the requirement for employment land between Sheet Road and Rocks Green provided that there is an allowance for further expansion of existing facilities with appropriate car parking and improved highway access.

A comprehensive, well planned and integrated development between both of these areas will ensure the growth of a cohesive community. By the addition of road, footpath and cycle ways linking these two areas it will enhance access to employment and other community facilities.

The Parish Council cannot see any benefit to the allocation of employment land ELR058 south of Sheet Road at the junction with the A49 and is totally opposed to this and it should be removed from the plan.

As this development is not between The Sheet and Rocks Green where the amount of land is enormous there is no justification to extend the land outside this area and into a new different location.

This site which is in close proximity to the only filling station in town and would add to the already unsatisfactory road system to the east of the A49 at The Sheet.

If there is a need and justification for additional employment land then it should be in the area between The Sheet and Rocks Green.
