It is **not legally compliant** because the inclusion of OSW004 without appropriate assessment to establish the heritage significance, and the contribution that setting makes to that heritage significance, of a statutorily protected ancient monument of national importance, and the substantial harm to the heritage significance of that scheduled monument (Old Oswestry Hillfort) which would be caused by 117 houses being constructed within a part of its setting that is of major importance for understanding and appreciation of its heritage significance.

It is **not positively prepared** because partiality has been shown by Shropshire Council in its inclusion of the promoter/developer's statements for OSW004, but failure to include on its website and to consider with equal weight the academic studies undertaken by those opposing the proposal. Shropshire Council has also ignored the warnings from other organizations that the promoter's background studies which have been used in support of OSW004, are inadequate and non-compliant with planning policy guidance.

The plan is not justified because it has failed to take full and proper notice of the wishes of the majority of the local community who largely oppose OSW004, including a petition against the site's inclusion signed by over 8000 people, and has failed to respond positively to the decisions and requests from Oswestry Town Council. It has also ignored the opposition from Selattyn and Gobowen parish councils. It has failed to adequately assess the impacts on the historic environment and visual amenity. Alternative sites exist, but Shropshire Council have not demonstrated that an adequate alternative sites assessment has been undertaken. Insufficient assessment on the local infrastructure, especially on highways and access, has been undertaken which would severely affect the northern and eastern approaches to Oswestry. The potential harm to the setting of the iconic hillfort is contrary to Shropshire's Core Strategy to enhance and conserve the historic environment, including scheduled monuments, such as Policy CS6 4.82, and CS17.

The plan would **not be effective** if OSW004 is included as it would be problematic to deliver the housing at this site as it clearly contradicts the national Planning Policy Framework section 12 on the Historic Environment, especially for example paragraph 132. English Heritage have stated that Shropshire Council should not presume they will not object to any development at OSW004.

Inclusion of OSW004 in the plan would **not be consistent with national policy**, in particular the NPPF section 12, paragraphs 131, 132. In addition paragraph 129 states that:

"Local planning authorities should identify and assess the particular significance of any heritage asset that may be affected by a proposal (including by development affecting the setting of a heritage asset) ...and should take this assessment into account when considering the impact of a proposal on a heritage asset..." whilst paragraph 137 stresses that: "Local planning authorities should look for opportunities for new development within...the setting of heritage assets to enhance or better reveal their significance. Proposals that preserve those elements of the setting that make a positive contribution to or better reveal the significance of the asset should be treated favourably."

This was made clear in the pre-submission draft of SAMDEV 12/3/2014 which states:

MD13. 4.139. Heritage assets are a finite, non-renewable resource and great care must therefore be taken when determining applications which result in a loss of significance, either partial or total. Proposals adversely affecting either the significance or setting of designated or non-designated heritage assets will therefore be rejected unless the harm to the significance of the asset is outweighed by the public benefits of the proposal and there are no satisfactory alternatives. In making this decision the significance of the asset, its level of importance, the degree of impact and opportunities for a viable beneficial use of the asset will be taken into account. Proposals which would result in harm, or a loss of significance, to a designated heritage asset, including the setting, will be determined in line with national policy.

Shropshire Council would be ignoring national planning policy if it continued to include OSW004 and would thus jeopardize its whole plan being accepted by an

inspector at public inquiry, and unnecessarily risks incurring considerable cost.
