Re: SAMDev proposed site OSW004 (off Whittington Road, Oswestry, in the setting of the Hillfort)

I refer to Shropshire Council's decision to include OSW004 by Old Oswestry Hillfort in the SAMDev draft plan due for final consultation. As you are fully aware:

- •This site through consultation has attracted overwhelming opposition locally, nationally and internationally: from English Heritage, Oswestry Town Council, Selattyn and Gobowen Parish Council; from countless heritage and environmental experts and organisations (English Heritage, RESCUE/The British Archaeological Trust, The Prehistoric Society, Council for the Protection of Rural England, The Society of Antiquaries of London among them); and from over 8,000 objectors via petition.
- •The government's NPPF, Shropshire's Adopted Core Strategy and English Heritage guidance require planners to protect heritage assets and their setting, especially those of national importance, against harmful development.
- •Expert reports submitted to you show that housing on OSW004 would have <u>major visual</u> and <u>landscape impacts</u> and <u>would substantially harm the hillfort's setting and historic landscape.</u> This is objective evidence based on tried and tested methodology published by the Landscape Institute, and used as standard in Environmental Impact Assessments.
- •Your assessment of heritage impact is based on a report from the site promoter that concludes impacts would be minor a report that experts have criticised in parts as being flawed and non-compliant with NPPF and which you admit to not having checked for compliance risk.
- •The need to meet Shropshire's 5-year housing target was stated as your main defence for retaining OSW004, but your own documentation states that 'SAMDev sites with significant unresolved issues' are not to be included in this target.
- •The presumption (once accepted as part of SAMDev) in favour of sustainable development will be established prior to the production of any detailed studies of impacts on the heritage asset and its setting, as required by NPPF. This makes the decision to include OSW004 in SAMDev premature.
- •There is no community mandate for OSW004 and this issue is not just of local but national and global interest. Both will carry great weight at public inquiry, at great risk to the Council financially, the reputation of its elected members and the confidence of the people of Shropshire.

Given that the Council has a legal responsibility to protect one of the nation's pre-eminent scheduled monuments, and to give due weight to public opinion within consultation on local decision-making, there is no defensible case to keep this remaining unresolved site in SAMDev.

We urge you to remove OSW004 from the SAMDev plan, and ask for acknowledgement of this letter.
