Research and fact finding insufficient:

- 1. The land west of Watling Street including CRAV002 was until the early 20thc. part of the Sibdon estate and CRAV002 occupies the site of a historic avenue focussing upon the east front of Sibdon Castle. This was probably laid out in c.1740 and may have carried the main drive to the Castle. It disappeared in the early 20thc. but elements of it still survive close to the Castle and close to Watling Street it is preserved as two parallel elm hedgerows within CRAV002.
- 2. Sibdon Castle is a Grade II* listed building and its curtilage and extended setting is protected by this designation. There has been no attempt to take into account PPS5, pars. 113-117 and the EH Revision Note, June 2012, on the setting of Heritage Assets.

- 3. The AONB includes the immediate ground surroundings of Sibdon Castle but in an arbitrary way, excludes some of the key elements of its setting, including its historic avenue. CRAV002 is in conflict with the aspirations of the AONB.
- 4. The Shropshire Way enters the historic setting of Sibdon Castle at Watling Street. The early part of the footpath will be adversely affected by CRAV002.
- 5. Watling Street is a highly sensitive archaeological feature. Its route and immediate hinterland should be protected.
- The AONB, Shropshire Way and Watling Street can also be regarded as Heritage Assets for which the setting needs to be protected.
- 6. The Sibdon estate has considerable landscape character and although partly protected by its position in the AONB, a larger area of the estate fulfils a number of the pre-conditions for registration as a historic park and garden.
- The landscape was in existence by c.1740.
- It was an influential example of its type and admired b one on the principal arbiters of contemporary taste in the mid-18thc. Later it is referred to in contemporary literature.
- It reflects the earliest stages of the English landscape style.
- It is associated with significant persons and movements.
- As indicated above it is associated with other heritage assets.

Mr. Holden has decided to go ahead with an application to English Heritage to seek consideration as a Registered landscape and this will be pursued in early May.
