Non compliance with SC6 which states that all development "protects, restores, conserves and enhances the natural, built and historic environment and is appropriate in scale, density, pattern and design taking into account the local context and character....."

With 52 houses on this site, below Helmeth Woods and highly visible from Carding Mill Valley and the Long Mynd, it is impossible to replicate the density of housing that the neighbouring developments of Battlefields Estate and Oakland Park. This site is a mile and a half from the school and a mile from the shops and there is no public bus route along Sandford Avenue. Sandford Avenue already suffers from traffic problems; poor visibility for access, speeding traffic, excessive noise from

motorbikes and trucks and a narrow pedestrian footpath on the south side of the street only. The additional traffic generated by 52 households will only worsen this situation
