Oswestry and Border History and Archaeology Group are objecting because keeping OSW004 in SAMDEV conflicts with all the listed points of soundness. The document has not been positively prepared, it is not justified, it is not effective and it is not consistent with national policy.

It is not legally compliant as OSW004 has been included without due consideration of the impact of a development of 117 houses on the heritage significance of the nationally important scheduled monument of Old Oswestry Hillfort. It would have a major detrimental effect on the views to and from the hillfort, and adversely affect the heritage significance of a site substantially unchanged for three millennia.

1. Not positively prepared.

There has been inadequate investigation of the potential archaeological significance of the proposed building site, and a failure to attend to or share advice other than that submitted by the developers, despite representations by other professionals and academics which have shown that this advice is inadequate and not in line with the NPPF.

2. Not justified.

The plan has failed to take into account local, national and international objections including a petition with over 8000 signatories and the accompanying pleas and requests for recognition of the unusual importance of the site from a host of eminent academics. Oswestry and Border History and Archaeology Group was established to enhance the understanding and appreciation of Oswestry's heritage, and are opposed to the plan, as are Oswestry Town Council, and Selattyn and Gobowen Councils. The plan fails to counter these numerous objections and has failed to explain why alternative strategies have not been pursued, including a more rigorous assessment of the potential of vacant sites within the town.

3. Not Effective

Any application for development of OSW004 would not be compliant with National Planning Policy Framework which in paragraph 131 states that in determining planning applications local planning authorities should take account of the desirability of sustaining and enhancing the significance of heritage assets and putting them to viable uses consistent with their conservation, and the positive contribution the conservation of heritage assets can make to sustainable communities by supporting their economic vitality.

The pre-submission draft of SAMDEV 12/3/2014 states in

MD13. 4.139. Heritage assets are a finite, non-renewable resource and great care must therefore be taken when determining applications which result in a loss of significance, either partial or total. Proposals adversely affecting either the significance or setting of designated or non-designated heritage assets will therefore be rejected unless the harm to the significance of the asset is outweighed by the public benefits of the proposal and there are no satisfactory alternatives. In making this decision the significance of the asset, its level of importance, the degree of impact and opportunities for a viable beneficial use of the asset will be taken into account. Proposals which would result in harm, or a loss of significance, to a designated heritage asset, including the setting, will be determined in line with national policy.

Oswestry is fortunate in possessing a heritage asset of national and international significance which contributes to the town's distinct identity. There are cultural links with the Oswestry born poet Wilfred Owen who may have been influenced by time spent training on the hillfort during World War 1. By directly impinging on a heritage asset the plan contradicts the guidance in MD13. 4.139.

4. Not consistent with national policy

Shropshire county council would be ignoring National Planning Policy Framework guidance which states that Local Planning Authorities should have a positive strategy for the conservation and enjoyment of the historic

environment. The present setting of the Old Oswestry Hillfort would be diminished rather than enhanced and the plan ignores the significance of the immediate hinterland to a nationally important monument.
