The concept of identifying Community Hubs and Clusters is supported.

However, it is considered that Hubs and Clusters should be identified on a criteria led basis and should be objectively assessed. It is not necessary for the settlements to already be sustainable, as the object of the exercise expressed in CS4 is to make the rural area 'more sustainable.'

Walford Heath is a small settlement that has no community facilities. It was originally proposed as a Community Cluster along with Oldwoods and Merrington. Between the three of them they stood a chance of improving their sustainability if development was to be permitted in them. In particular they would have maintained a critical mass of people which would justify maintaining the local bus service.

However, the Parish Council changed its mind with regard to Oldwoods and Merrington and Walford Heath is now to be a Cluster by itself. This neither logical nor reasonable, given the length of time that it has been regarded as a Community Cluster, and will not achieve the stated aim of making the rural area more sustainable.
