The concept of identifying Community Hubs and Clusters is supported.

The idea of identifying Cockshutt as a Community Hub is supported.

However, the idea that a settlement that enjoys a good level of local community facilities, including a primary school, village shop and an regular bus service , and is clearly a sustainable settlement should be limited to a growth rate of just 50 dwellings in the period 2006 – 2026 is inappropriate and unlikely to make the rural are more sustainable, and make good and efficient use of existing services.

Further, two of the sites currently identified as housing sites in the draft SAMDev DPD have access and possibly third party land ownership

restrictions which mean they cannot be relied upon as being delivered within the plan period. The current suggested level has resulted from representations from the Parish Council and is not the result of any objective assessment of the capacity of the settlement to accept further development.

The village is considered capable of accepting a greater level of development, and further sites for housing development should be identified.

Cochshutt should be re-examined with a view to

- a) Increasing the number of new properties that will be permitted in the village,
- b) Assessing the viability of the sites currently identified for development to see if they are genuinely available and deliverable, and
- c) Other sites, including the site to the east of Shrewsbury Road and to the north of the village telephone exchange building, should be investigated and allocated for development.

This would make better use of existing facilities and might assist in making the rural area more sustainable.
