The concept of identifying Ellesmere as a Market Town where some 800 dwelling should be constructed in the plan period is supported.

However, it is considered inappropriate to limit development opportunities to just a single site. This could lead to a failure to deliver the appropriate number of houses and will limit choice for potential home owners in terms of location and house types. It is too risky a strategy for the number of dwellings involved especially as the site identified has a history of underdelivery.

The possibilities for development in Ellesmere should be reassessed and further sites should be allocated in order to ensure the delivery of the appropriate number of houses for the town.

The land off Bramble Ridge, Elson Road, that was identified for development as a preferred option in the earlier version of the SAMDev DPD should be allocated for housing development. This will bring competition and choice to the market, reduce risk in the provision of housing in Ellesmere, and help make it a more sustainable community.
