The concept of identifying Community Hubs and Clusters is supported.

However, it is considered that Hubs and Clusters should be based on settlements that have existing local services and are either sustainable or approaching being sustainable community. To avoid allocating development to such settlements is wasteful of existing resources, and will not make the rural area more sustainable.

West Felton, enjoys a primary school, a village shop, village hall, public houses, Church and has employment opportunities, and is a sustainable settlement. Nevertheless it has not been identified to accept any development in the SAMDev document. This is a waste of existing resources and will not make the rural area more sustainable. The decision not to allow any development has been made on the expressed desire of the Parish Council but has not taken place on the basis of

any objective assessment of the capacity of the settlement to accept further development.
