Bomere Heath is a settlement that has a good range of local facilities and services and is a sustainable settlement. Further development in the village will make good and efficient use of those existing services and will help ensure the provision of better and further facilities for the residents of the settlement.

The choice of site Site Ref BOM004 as the site allocated for development in the village will ensure early delivery of the houses as the land is already in the hands of a local developer. It is well sited in relation to the village facilities but also, because of its location to the south of the village, traffic generated by the development will not have to travel through the village to access Shrewsbury or the major employment areas at Harlescott and Leaton.
