Para 5.2 states that "the particular feature for which the River Clun SAC is notified is the Freshwater Pearl Mussel." This is incorrect – the Joint Nature Conservation Committee's (JNCC) Site Details for the River Clun lists under Annex II "species present as a qualifying feature, but not a primary reason for site selection" and goes on to list 6 species which include FWPMs.

It should also be noted that the SAC starts over 10,000 metres (as the crow flies) south of Lydbury North and that many of the sampling figures are 6 years out of date (from 2008).

The Nutrient Management Plan (NMP) remains a draft document, and even when

finalised will be an 'iterative' rather than 'definitive' plan requiring many years of research until firm conclusions can be reached. In the meantime the draft contains wholely unrealistic targets for reducing Phosphate levels to .01mg/litre in order to save the remaining FWPMs which the darft NMP declared to be 'non functional'.

We therefore conclude that **Policy S2.3.1** is seriously flawed in that it will be impossible to "clearly demonstrate that ...development in the River Clun catchment... will not adversely affect the integrity of the SAC".

This view is reinforced by Shropshire Council's guidance note 12 which states in paragraph 3.2 "with the nutrient management plan in production and with a very tight target for phosphate in the catchment (0.02mg/l) it is difficult to calculate an insignificant load of phosphate to the river (and so support a conclusion of 'likely to have no significant effect' when completing the in-combination test)"

All settlement policies S2.1-S2.2 (iv) in the Bishop Castle place plan area and within the Clun river catchment have reference to "the nutrient management plan and agreed management strategy for the river catchment". As already refered to above, currently there is not a NMP in place or an agreed management strategy. The NMP was meant to have been completed before the end of 2013, then the end of April 2014. The designation of the SAC on the river Clun recognises the habitat as of international importance and therefore its protection is set out in statute. It is therefore not nessecary to refer to a document which is yet to be published to try and further ensure the SAC's protection as there is adequate protection under the adopted Core Strategy policies CS 17, CS18 and CS19 together with policy MD12 in the draft SAMDEV.
