Chartwell Development Limited own the land at Chartwell Business Park, Stourbridge Road, Bridgnorth and is pleased to note that in paragraph 5.27 the Council recognise the existing retail planning permissions, and the suitability of the site for retail development. The Company however wish the Council to be aware that it is in the process of preparing revised retail development proposals, including the provision of a petrol filling station fronting onto Stourbridge Road, and these will be the subject of a planning application to be made in the near future.

The proposals are likely to cover an area of approximately 2.4 hectares, including access, internal estate road and embankments. The proposals will supplant the area of the existing permissions with the exception of an area amounting to approximately 0.3 hectares upon which the Company would wish to implement one

of the approved retail units. Accordingly should planning permission be granted for the revised proposals the area of land available for employment uses (Classes B1, B2 & B8) would be reduced to approximately 2.5 hectares net.

The Company recognises that until such time as planning permission is granted for the revised proposals significant weight cannot be given to the above but, nevertheless the Company considers the Council should ensure greater flexibility is built into the Plan by either reducing the potential area available for employment uses or by adding a note that the area available is subject to change.

This amendment is considered desirable to ensure the effectiveness of the Plan.


