Tasley Estates consider for the plan to be *effective* there should be flexibility in the wording to ensure in a dynamic environment the best possible chance of delivery. With this in mind Policy S3.1b: Employment Sites allocation south of A458 (ELR011/b) should be amended to allow the relocation of the livestock market and its existing *'or alternative'* ancillary uses only. There are currently a number of ancillary uses that support the livestock market and secure its existence which are considered as one entity for the purposes of this policy. However, uses come and go over time depending on market conditions and it may be that other ancillary uses are equally appropriate to the existing uses, for example, AMC Bank that specialise in agricultural accounts are not currently present but would be a suitable ancillary use.
