Tasley Estates supports the allocation of 1,400 homes and new employment land but considers the statement that '*around 19 hectares of employment land will be delivered*' as misleading and in need of clarification as this is not all new employment land. Furthermore, the Schedules references are incorrect and should refer to S3a and S3b.

The intention is to relocate the existing livestock market and its ancillary uses to a new site of 6.6 hectares (ELR011/b) in order to facilitate delivery of housing and mixed use development north of Wenlock Road and north of Church Lane (BRID001/BRID020b) (BRID020a). The allocations are not mutually exclusive and are a comprehensive package such that the new livestock market will not coexist

with the old market. As a result the existing site of the livestock market of 6.6 hectares will be lost from employment use therefore the net addition to employment land is actually just over 12 hectares (19 hectares minus 6.6 hectares).

To be *effective* the policy should be expanded.
