The Parish Council supports the plan for Lydbury North and believes that the process that has taken place to deliver this policy is both legally compliant and sound.

Lydbury North Parish Council objects to the area wide policy as stated under section S2.3 and explained under 5.20 and 5.21 of the River Clun Special Area of Conservation on the basis of being unsound as a result of factual information being unjustified as explained below. The Parish Council is concerned about the consequent implications for this aspect of the policy on the 5 year housing supply.

5.20 states that "the particular feature for which the River Clun SAC is notified is the Freshwater Pearl Mussel." This is incorrect – the Joint Nature

Conservation Committee's (JNCC) Site Details for the River Clun lists under Annex II "species present as a qualifying feature, but not a primary reason for site selection" and goes on to list 6 species which include FWPMs.

It should also be noted that the SAC starts some 10km from Lydbury North and that many of the sampling figures are 6 years out of date (from 2008).

The Nutrient Management Plan (NMP) remains a draft document, and even when finalised will be an 'iterative' rather than 'definitive' plan requiring many years of research until firm conclusions can be reached. In the meantime it contains wholly unrealistic targets for reducing Phosphate levels to .01mg/litre in order to save the remaining FWPMs which are declared to be 'functionally extinct'.

We therefore conclude that **Policy S2.3.1** is seriously flawed in that it will be impossible to "clearly demonstrate that ...development in the River Clun catchment... will not adversely affect the integrity of the SAC".

The hindrance to development in the River Clun catchment may seriously impact on capacity to meet the Government five year housing supply targets.

In order to address the soundness of the policy under section S2.3 and as explained under 5.20 and 5.21 Lydbury North Parish Council believe that there should be:

- a) Specific reference to phosphate stripping at the sewage treatment plant in Lydbury North and Clun in order to meet water quality requirements on nutrient loads .
- b) The need for up to date data on which to draw appropriate conclusions and as a consequence a policy for the Clun Valley that is 'proportionate' to the risk.
