This SAMDev plan has accordingly excluded development on the western side of Whitchurch with its well known infrastructure constraints such as highways, (traffic congestion and unsafe cycle and pedestrian access into town along Wrexham Road), waste water issues, distance from the town, the schools, the employment site and the train station.
