**This SAMDev plan has accordingly excluded development on the western side of Whitchurch with its well known infrastructure constraints especially highways, (traffic congestion plus unsafe cycle and pedestrian access into town along Wrexham Road), waste water issues, and the distance from the town, all the schools, the employment sites and the train station.**
