The site formerly branded as the Shropshire Food Enterprise Park (SFEP) was not allocated for development in the Shrewsbury & Atcham Local Plan and is identified as open countryside (L-shaped site delineated by the A5124 to the north, Battlefield Way to the west, the railway line to the east and Vanguard Way/site of the Waste Management site to the south).



Outline planning permission (02/1429/O) was granted for the site on 1 October 2003 by Shrewsbury & Atcham BC (SABC) for the 'use of land for organic and non-organic food related B1, B2, B8 uses to include means of vehicular and pedestrian access (amended description)'

A reserved matters application associated with outline planning permission 02/1429/O was however never submitted and the planning permission accordingly lapsed (refer to paragraph 26 of Appeal Decision APP/L3245/A/11/2146219).

As a consequence, with the exception of unauthorised access roads, the site remained open countryside.

Notwithstanding its open countryside status, full planning permission has been granted for :

- the Food Enterprise Centre (06/1117/F); and
- the Mercedes car dealership (12/03574/FUL)

The Food Enterprise Centre development was constructed some years ago whilst the Mercedes car dealership development is currently under construction. Both of these developments are located within the southern portion of the former SFEP site, adjacent to Vanguard Way.

The site of the former SFEP does not benefit from any other significant extant planning permissions, has never been allocated for development, is undeveloped and remains open countryside.

Notwithstanding this, the undeveloped, unallocated, open countryside area (between the A5124 and Battlefield Brook) has been identified on Shrewsbury Area S16-Inset 1 map as part of a 'Protected Employment Area'.

Policy MD9 explicitly deals with 'Existing Employment Areas' and the Explanation to Policy MD9 reinforces that the policy is concerned with the protection of <u>existing</u> employment areas.

The area in question between the A5124 and Battlefield Brook is not however an existing employment area. It has never been allocated for employment uses, it has never been lawfully developed for employment uses, it does not benefit from any extant planning permissions for employment uses and is currently open countryside.

This area should not therefore be designated as a Protected Employment Area.

If the Council is minded to see this area developed for employment uses, then proper approach would have been to propose it for an Employment Allocation under Policy MD4 and to delineate it as such on Shrewsbury Area S16- Inset 1.

However in doing so, the Council would need to demonstrate that the site had undergone a thorough assessment (including Sustainability Appraisal) as with other sites proposed for allocation.

Assessments of the site under successive Employment Land Reviews (and the Strategic Sites and Employment Areas Assessment) have repeatedly failed to acknowledge, let alone consider, the proximity of the site to the Registered Battlefield or the potential implications of development on its setting and significance as a heritage asset.

In doing so, proper regard would need to be had to ecological considerations (including a breeding colony of great crested newts and badgers which are known to be present within the area), the site of the Registered Battlefield of Shrewsbury which is a designated heritage asset of the highest importance (part of which is included within the proposed Protected Employment Area) and its setting.

It is also noted that the Strategic Sites and Employment Areas Assessment has erroneously indicated or inferred that the site still benefits from lapsed outline planning permission 02/1429/O.

The identification of this area as a 'Protected Employment Area' is a backdoor attempt by the Council to allocate the area, circumventing due process and proper assessment. In that respect it is noted that the area was not shown as being proposed for an employment allocation nor was it shown as being part of a Protected Employment Area within the previous version of the SAMDev.

Shrewsbury Area S16 – Inset 1 Map should be amended. The remaining area of open countryside to the east of Battlefield Way between Battlefield Brook to the south and the A5124 to the north should be not be identified as a Protected Employment Area and should instead be shown as open countryside.
