We object to paragraphs 1 and 2 of Policy S10.

The supporting text identifies that 358 dwellings need to be delivered in the remainder of the plan period. The allocated sites in Ludlow would deliver approximately 280 dwellings and Shropshire Council is relying on the remainder being delivered through windfall sites within the development boundary. The development boundary is tightly drawn around Ludlow and it is unlikely that approximately 80 dwellings would come forward as windfall sites over the plan period. The opportunity at Foldgate Lane could deliver additional housing growth within the plan period.

We therefore consider this Policy not to be deliverable over the plan period.

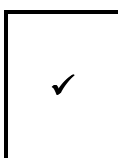
Further to our representation on Policy MD1 (Scale and Distribution of Development) paragraph 1 should be amended to reflect an extended plan period.

Paragraph 2 needs to be amended to remove the reference to sites east of the A49, which in our view are more remote and less sustainable than Foldgate Lane. The Policies Map needs to be amended accordingly.
