I consider the plan is not positively prepared in that the assessed development and infrastructure requirements differ too greatly from the figures which logically derive from the previous stages and results of the consultation process. This process, starting from the 2010 Issues and Options Consultation, 'Planning for a Flourishing Shropshire', achieved in a positive manner what appeared to be a logical and reasonable scenario for the future expansion of Bridgnorth up to 2026. During the process the inadvisability of allowing development to cross the A458, instead siting additional employment and residential facilities to the north of the bypass, retaining the maximum figure of 1.000 new homes, as also in line with the Core Plan indicative figure, became clear. This obviated the need for the additional ELR011/a and b site across the bypass. The figure of 1,400 new homes appearing in Policy CS2.1:2, a considerable increase on any figure previously mentioned, has little positive justification, merely that the SAMDev has firmed up the levels of development having regard to inter alia the consultation responses.

I do not consider the Plan was justified, again because of the disjunction between the consultation responses and the final decisions. Also there is no assessment of the landscape sensitivity associated with relocating the livestock market and providing additional employment land across the bypass, to comply with para. 170 of the NPPF. Policy 159 of the NPPF requires a Strategic Market Housing Assessment. On page 25 of the draft Plan Housing Assessments for 2008 and 2014 are cited as key evidence. The 2008 Assessment I have previously seen but I am unable to track one for 2014. (The Bridgnorth Civic Society requested an up to date assessment two years ago.) Also there is a lack of emphasis on the need of affordable housing which is cause for concern. I also question whether the employment land allocation is appropriate, given the level of unused employment land at Chartwell Business Park, laid out with full facilities, and the Stanmore Industrial Estate. I also consider the Plan not effective for the same reason that the planned infrastructure delivery is not sustainable and therefore not sound. I do not think that the proposed removal of the Livestock Market to a more landscape sensitive site across the bypass together with a new traffic roundabout is sustainable. The bypass

Para. 57 of the NPPF states the need to plan positively for the achievement of high quality and inclusive design for all developments. The uncorroborated statement merely that an approach that enables good design and quality standards becomes more feasible at higher standards of development (Sustainability Appraisal Bridgnorth Supplement) is not sufficient. So I think the Plan is not fully consistent with National Policy.
