The Core Strategy policy to concentrate development in Shrewsbury is supported.

However, whilst there are a number of sites allocated for development, it is questionable as to whether they are all going to be fully built out and therefore all of the houses delivered within the lifetime of the SAMDev DPD. The delivery of the appropriate level of housing rests heavily on two SUE's and two other very large sites. If any one of these sites should fail to come forward the plan will not produce the housing that is necessary. None has yet got underway. The strategy adopted might well fail to produce the housing required, and so needs to be modified.

The allocation of additional sites, perhaps smaller and therefore not needing such significant infrastructure installations, would increase the likelihood of

the targets for Shrewsbury being met. In this way targets for affordable housing will also be met.
