

# **Non-Technical Summary**

*The following report represents the results of archaeological desk based appraisals and site visits undertaken in respect of three areas of land within the village of Lydbury North, Shropshire, prior to the proposed inclusion of the three areas within a Village Development Plan.*

*The work was undertaken by Archaeology Wales on behalf of Balfours LLP.*

*The most northerly of the three areas is located to the immediate north-east of the 12<sup>th</sup> century church of St Michael, whilst the central and southern assessment areas are located on the south-east outskirts of the village across the route of the pre-turnpike road. A modern BT Telephone Exchange has also been constructed over the line of the road in this area.*

*The desk based appraisal has shown that the northerly assessment area was likely to have been located within the historic medieval core of the village, whilst the two remaining plots probably remained outside the village. The central and southern plots were bisected by the line of the medieval road to Lydbury North from the east, which is still visible as a cropmark.*

*Each of the three areas has the potential to contain important archaeological features. However, the potential is greatest in the northern area, which is located within the medieval village, adjacent to two hollow ways, and close to a find spot of Roman date. In the central and southern areas there is a potential for archaeological discoveries associated with structures and features located along the northern and southern frontage of the medieval road.*

## **1 Introduction**

### **1.1 Scope of work**

- 1.1.1 In August 2014 Archaeology Wales Ltd (AW) was commissioned by Balfours LLP to carry out archaeological desk based appraisals and site walkover visits on three plots of land at Lydbury North, Shropshire (NGR SO 35277 86092, 35310 85923, 35315 85857 - Figs 1&2).
- 1.1.2 The work is being undertaken with a view to advising on likely archaeological constraints prior to the possible submission of planning applications for housing development and associated infrastructure at the three sites.

- 1.1.3 The work includes a study of data recorded on the HER held by Shropshire County Council, map regression analysis, an assessment of previous (published and unpublished) archaeological investigations and a site walkover.

## **1.2 Geology**

- 1.2.1 The underlying solid geology of the assessment area is composed of limestone in the Ludlow series from the Silurian era (Geological Survey Map, 2001).
- 1.2.2 The subsoils covering the assessment area are described as freely draining, loamy soils with shallow groundwater tables (Geological Survey Map, 2001).

## **1.3 Site Location and Topography**

- 1.3.1 The assessment areas are located at between 155 and 160m above Ordnance Datum with the northerly assessment area being the highest of the three. Each is relatively flat in topographic profile and all are currently in use as grazing land.
- 1.3.2 The most northerly area, located to the immediate north east of the church of St Michael, covers a total of 2873m<sup>2</sup> and is comprised of one roughly rectangular field aligned north-south and one area of grass verge adjoining the southern end.
- 1.3.3 The central area, located on the south east outskirts of the village, covers a total of 1663m<sup>2</sup> and again comprises one roughly rectangular field.
- 1.3.4 The southern area, to the south of the central area and similarly on the outskirts of the village, covers a total of 2107m<sup>2</sup> and again comprises one roughly rectangular field.

## **1.4 Archaeological and Historical Background**

- 1.4.1 The three assessment areas are all located within the modern village of Lydbury North. The name Lydbury (Lideberie) is first mentioned in the Domesday Book of 1086. The 'north' element is first documented in 1254 (although there is no mention then, or subsequently, of Lydbury South) (Foxall, 1980).
- 1.4.2 The Domesday Book entry refers to Lydbury as being held by the Bishop of Hereford from the king and that he held it before 1066. It is therefore likely that the village is at least of late Saxon origin.
- 1.4.3 The church of St Michael, with its roughly square-shaped graveyard, appears to form the central focus point of the village. Although the earliest fabric of the church dates from the 12<sup>th</sup> century (Salter, 1988), its prominent position within the centre of what is known to be a Saxon settlement suggests strongly that there is an earlier structure on the site.
- 1.4.4 No archaeological excavations have taken place within Lydbury North so what little is known about the medieval village is inferred from later maps and from the road layout. No distinct topographical evidence of burgage plots remains anywhere within the village.

- 1.4.5 The course of the main east to west road through the village, the B4385, is the route of a turnpike road constructed at the end of the 18<sup>th</sup> century. Prior to its construction, the main east to west road may have skirted southwards around the outside of the village (Greene, 2009).
- 1.4.6 In 2009, as part of investigations by the Lydbury Field Group, a group of older buildings within the village were subject to dendro-chronological dating. Of the structures tested, the oldest (Building 5 – Old Farmhouse located adjacent to the northerly assessment area) contained timbers dating from between 1630 and 1660 (Greene, 2009). It seems reasonable to conclude, therefore, that the 12<sup>th</sup> century church is not only the earliest building in the village, but also the only one of medieval origin.
- 1.4.7 To the immediate south of the village is the large 18<sup>th</sup> century Walcot estate, which includes of two large lakes, various ponds, woodland, parkland, botanical gardens and a large hall. The estate was purchased from the Walcots by Lord Clive of India in 1764 (Harvey, 1999).

## **2 Aims and Objectives**

### **2.1 Desk Based Appraisal**

2.1.1 The desk based appraisal was undertaken to:

- Assess the likely impact of any future development proposals on the historic environment
- To place the results of the work in its historic context
- To aid and inform any potential future archaeological or mitigation work undertaken at the site.

## **3 Methodology**

### **3.1 Desk Based Appraisal**

3.1.1 As part of the desk based appraisal, the following repositories were consulted for readily available information:

- The regional HER database for the locations of all known archaeology (Monuments, Events) within a 500m radius from the assessment area boundary and previously undertaken published/unpublished works
- The regional library for all material relating to local studies within Lydbury North

- Internet sourced satellite imagery
- 3.1.2 The site visits and the overall management of the project were undertaken by Chris E Smith (MifA). All areas were photographed using high resolution digital photography in RAW format.
- 3.1.3 All works were undertaken in accordance with the IfA's *Standards and Guidance for an archaeological desk based assessment* (2008, revised 2011).

## 4 HER Search

### 4.1 HER Data – Historic Landscape Characterisation Areas (Fig 3)

- 4.1.1 A search of the regional HER (Shrewsbury) has shown that the northern assessment area is located within a historic landscape character area defined as being 'pre-1880s settlement' (HSA11710).
- 4.1.2 The central assessment area is located within a historic landscape character area defined as being 'post-1880s settlement' (HSA11706).
- 4.1.3 The southern assessment area is located within a historic landscape character area defined as being 'landscapes composed of small, irregular, fields' (HSA11704).
- 4.1.4 A full HER gazetteer is contained within Appendix 3.

### 4.2 HER Data – Events Polygons (Fig 4)

- 4.2.1 A search of the HER data returned a total of 10 archaeological events recorded as taking place within a 500m radius of each assessment area.
- 4.2.2 All of the events (listed below) were undertaken by, or on behalf of, the Lydbury Field Group for their publication 'The Making of the Lydbury Landscape: Six Thousand Years of Human Intervention' (Greene, 2009).
- 4.2.3 The 10 archaeological events are:
- 2288 – 2005 Geophysical survey at Lower Gardens, Lydbury
  - 3065 – 2005 Excavation at Lower Gardens, Lydbury

- 4.2.4 The full HER gazetteer entries are contained in Appendix 3.



### **4.3 HER Data – Monument Polygons (Fig 5)**

4.3.1 A search of the regional HER (Shrewsbury) revealed a total of 3 HER monument polygons located within a 500m radius of the assessment area boundary. These are:

- 4712 – The post-medieval farmstead
- 4156 – Former field boundaries and water features at Lower Gardens
- 5713 – Walcot Hall parkland

4.3.2 The full HER gazetteer entries are contained in Appendix 3.

### **4.4 HER Data – Monument Points (Figs 6&7)**

4.4.1 The vast majority of the 50 HER data points relate to standing buildings or structures located within Lydbury North. With the exception of the church, these cannot be shown to pre-date the mid-17<sup>th</sup> century:

#### **4.5 HER Data – Summary**

- 4.5.1 The general lack of information about medieval activity within the village of Lydbury North is reflected in the HER data, with only one structure, St Michaels Church, being shown as medieval.
- 4.5.2 With the exception of data point 9717, the remainder of the data relates to features of 17<sup>th</sup> to 20<sup>th</sup> century date.
- 4.5.3 Analysis of the Events Data also shows that no archaeological work has been undertaken within the village of Lydbury itself.
- 4.5.4 Data point 9717 relates to a single find, made in 1954, of a Roman bronze figurine. This is recorded as being recovered only 15m from the boundary of the northern assessment area. This may, however, represent a chance loss.

## **5 Map Regression**

### **5.1 Maps**

- 5.1.1 Maps were consulted dating from 1836 to 1949. They included all available Ordnance Survey maps and the parish Tithe map.

### **5.2 Map Regression**

- 5.2.1 1836 One Inch 1<sup>st</sup> Series OS Map (Fig 8)

The 1836 map shows each of the assessment areas in reasonably clear detail.

The northerly assessment area is depicted as a roughly triangular open space with no features marked within it.

The central and southern areas (merged as one for ease of description) are similarly depicted as being undeveloped open space. No further features were noted.

- 5.2.2 1846 Lydbury North Parish Tithe Map (Fig 9)

The 1846 tithe map transcription shows the assessment areas in very clear detail. Each is still shown as undeveloped open space. The northerly assessment area is named as Orchard whilst the central and southern assessment areas are merged into a single land parcel named Mill Close. No further features were noted.

#### 5.2.3 1890 1<sup>st</sup> Ed 6 Inch OS Map (Fig 10)

The 1890 OS map shows the assessment areas in very clear detail. Both the northern and central assessment areas are shown as orchards whilst the southern site is shown as still undeveloped. A sluice is marked adjacent to the southerly boundary of the southern area. No further features were noted.

#### 5.2.4 1903 2<sup>nd</sup> Ed 6 Inch OS map (Fig 11)

The 1903 OS map shows no change within the assessment areas from that depicted on the 1890 map.

#### 5.2.5 1949 Provisional Ed 6 Inch OS map (Fig 12)

The 1949 OS map shows no change within the assessment areas from that depicted on the earlier 1903 map.

#### 5.2.6 1999 and 2009 Google Earth Satellite Images (Fig 13)

The two modern satellite images shows that the assessment areas have undergone very little change since the earliest available map (1<sup>st</sup> Series OS) was drawn up in 1836 (Fig 8). Each area is still depicted as undeveloped open space.

However, the division between the central and southern areas has been made more distinct by the addition of telephone exchange building. Examination of the images shows that the building was constructed before 1999.

The two images, particularly that dating to 1999, also show with some clarity the well-defined line of the pre-turnpike road. The road is visible as a cropmark, branching off from the B4385 east of the village, and heading south west. It bisects the central and southern assessment areas and is partially overlaid by the telephone exchange building. The cropmark (Fig 13) appears to show a reasonably wide road flanked on either side by a roadside ditch. No further features were noted.

### 5.3 Map Regression Summary

5.3.1 According to the cartographic analysis, the assessment areas have remained largely unchanged for at least the last 178 years.

5.3.2 The late twentieth century addition (before 1999) of a telephone exchange building appears to represent the only development in any of the three areas.

5.3.3 The modern satellite image shows the well-defined line of the medieval road and roadside ditches heading towards the central and southern assessment areas. However,

the construction of the telephone exchange building is likely to have damaged a lot of the road within its footprint. The road and road ditches are only likely to be preserved within the northern and southern extremities of the two assessment areas.

## **6 Site Visits**

- 6.1.1 Site visits were undertaken on 29th August 2014. The weather was overcast, but visibility was good. All parts of each of the three assessment areas were examined (Plates 1-15).
- 6.1.2 The northerly assessment area is composed of a roughly rectangular field and a small area of grass verge. Two separate, but converging, lanes run along the eastern and northern edges of the field. It is noticeable that the field is higher than either of the lanes. This suggests that they are likely to have formed as hollow ways, dating from the medieval period or earlier.
- 6.1.3 The northerly assessment area has a view of the tower of St Michael's church and is itself visible from the graveyard.
- 6.1.4 The central assessment area consists of a roughly rectangular field located to the rear of a former Land Rover garage and adjacent to the north to south aligned lane at Lower Gardens.
- 6.1.5 No features of archaeological or historic significance were noted within the central assessment area. The line of the pre-turnpike road is not visible as an earthwork in this area.
- 6.1.6 Until recently, the southern assessment area appears to have been part of the larger field located further to the east. It is therefore likely to have been regularly ploughed. A hedgerow now separates the two fields.
- 6.1.7 The field is again roughly rectangular in shape and flat in topographic profile. The fence which now defines the western edge of the field appears to have replaced an earlier stone wall, as wall remnants are visible within the grass and a corner section is still extant adjacent to the modern telephone exchange.
- 6.1.8 The line of the pre-turnpike road is not visible as an earthwork within the field. No features of archaeological or historic significance were noted.

### **6.2 Site Visit Summary**

- 6.2.1 No previously unknown archaeological or historical features or sites were located during the site visits. However, it was noted that the lanes adjacent to the eastern and northern sides of the northern assessment area are likely to have formed as hollow ways, and therefore date from at least the medieval period.

- 6.2.2 Of the three assessment areas, only the northern one has a view of any high value heritage sites, in this case St Michael's Church. Possible impacts on the setting of the church should be considered if development is proposed in this area. However, it should be noted that any such impacts are likely to be lessened, because of the amount of modern development that has already been undertaken in this area, a large amount of which is already clearly visible from the church.

## **7 Discussion**

### **7.1 Conclusions**

- 7.1.1 The desk based appraisals, combined with the walkover surveys, have shown that of the three areas, only the northern one is likely to have been located within the historic core of the medieval village. This is shown in the postulated village development plan (figure 14).
- 7.1.2 In terms of the topographical development of the historic core, it appears that the village represent an agglomeration of separate features rather than the result of any systematic plan (Roberts, 1982), which further suggests an Anglo-Saxon rather than a Norman origin. Figure 14 is based on the village development as documented by Greene (2009) as well the evidence from the historic maps and the site walkover surveys.
- 7.1.3 Although the northern area was located within the historic core of the village, it may still have served as an agricultural area. There is no evidence of features and the site is referred to as an orchard on the tithe map.
- 7.1.4 The central and southern areas appear to have been located outside the confines of the medieval village and are likely to have served as agricultural space. This part of the village is named Mill Close on the tithe map and the presence of a sluice at the southern end of the southern assessment area suggests a mill is located in the vicinity.
- 7.1.5 The pre-turnpike road is likely to survive as a preserved archaeological feature, although only at the very northern end of the southern area and southern end of the central area. Although the positioning of the telephone exchange is likely to have damaged the feature in this area, the surviving remnants could still provide important archaeological evidence of the village and its possible pre-medieval origins.
- 7.1.6 The location in 1954 of a bronze figurine of Roman date, only 15m from the northern assessment area, is also of potential archaeological significance. Similarly it may represent a chance loss.

### **7.2 Potential**

- 7.2.1 Each of the three areas has the potential to contain important archaeological features. However, the potential is greatest in the northern area, which is located within the

medieval village, adjacent to two hollow ways, and close to the find spot of the Roman figurine.

- 7.2.2 The most significant feature located in the central and southern areas is the pre-turnpike road and there is a potential for archaeological discoveries in both of these areas, possibly those associated with structures and features located along the northern and southern road frontages.
- 7.2.3 The southern area appears to have formed part of a ploughed field until very recently, so shallow features are less likely to survive in this area.

### **7.3 Proposed Mitigation**

- 7.3.1 In order to inform future decision making for the three sites, archaeological mitigation could be considered to ensure the least possible impact on the archaeological resource.
- 7.3.2 A geophysical survey undertaken across the three assessment areas would provide a good indication of any possible archaeological features and their locations. Given the comparatively small size of the plots, a resistivity survey is suggested rather than magnetometry.

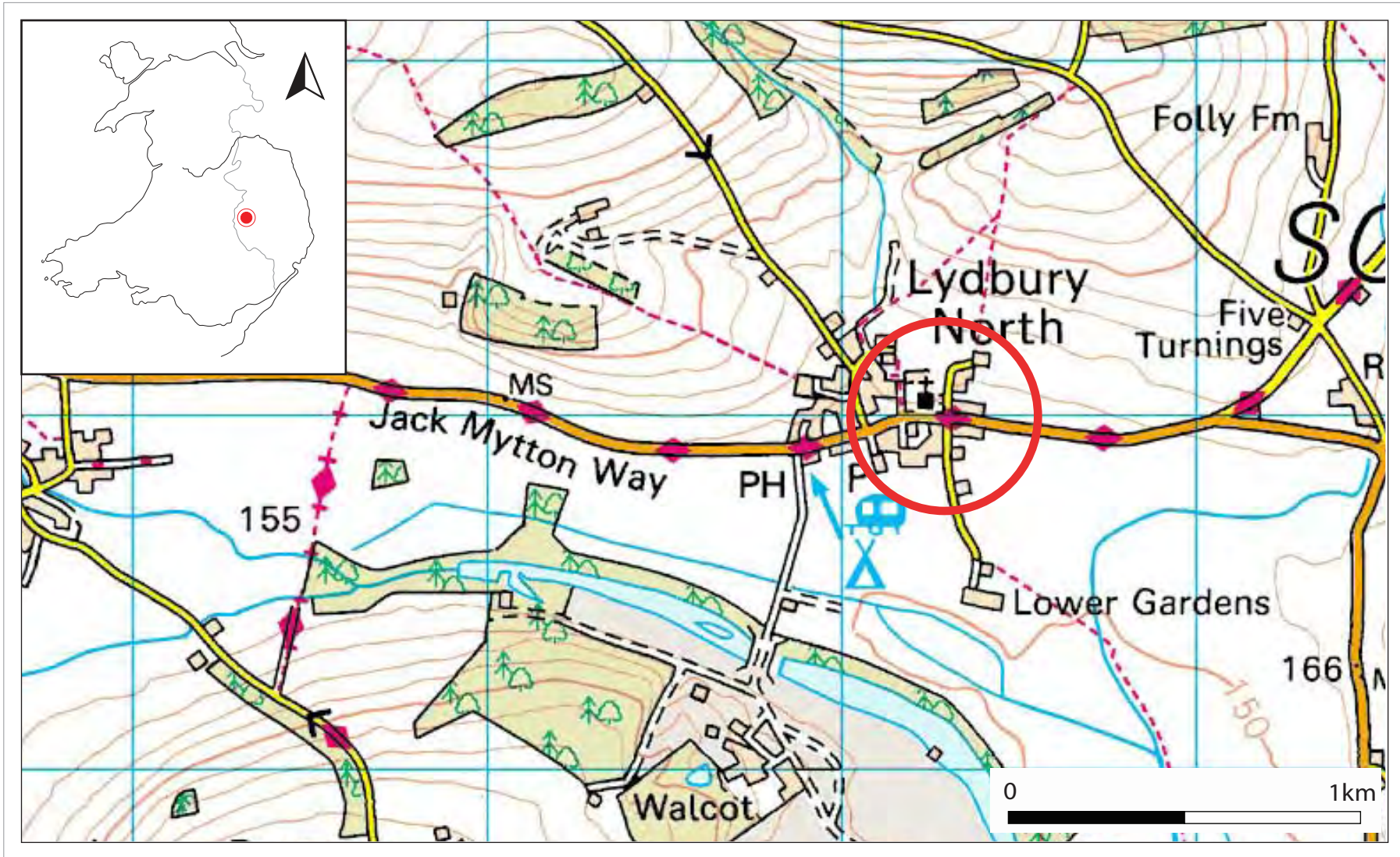


Fig 1: Map showing location of assessment area

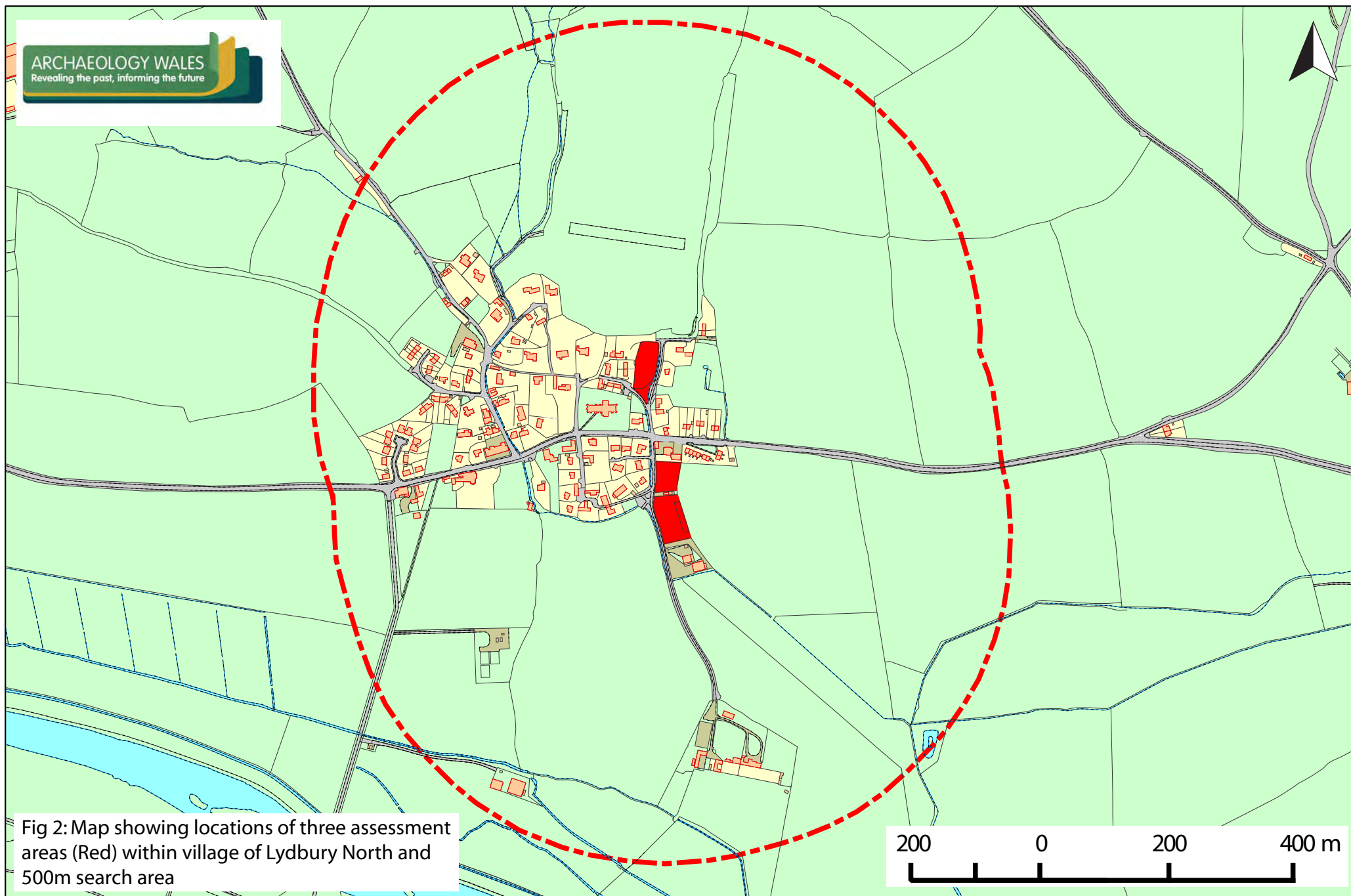


Fig 2: Map showing locations of three assessment areas (Red) within village of Lydbury North and 500m search area

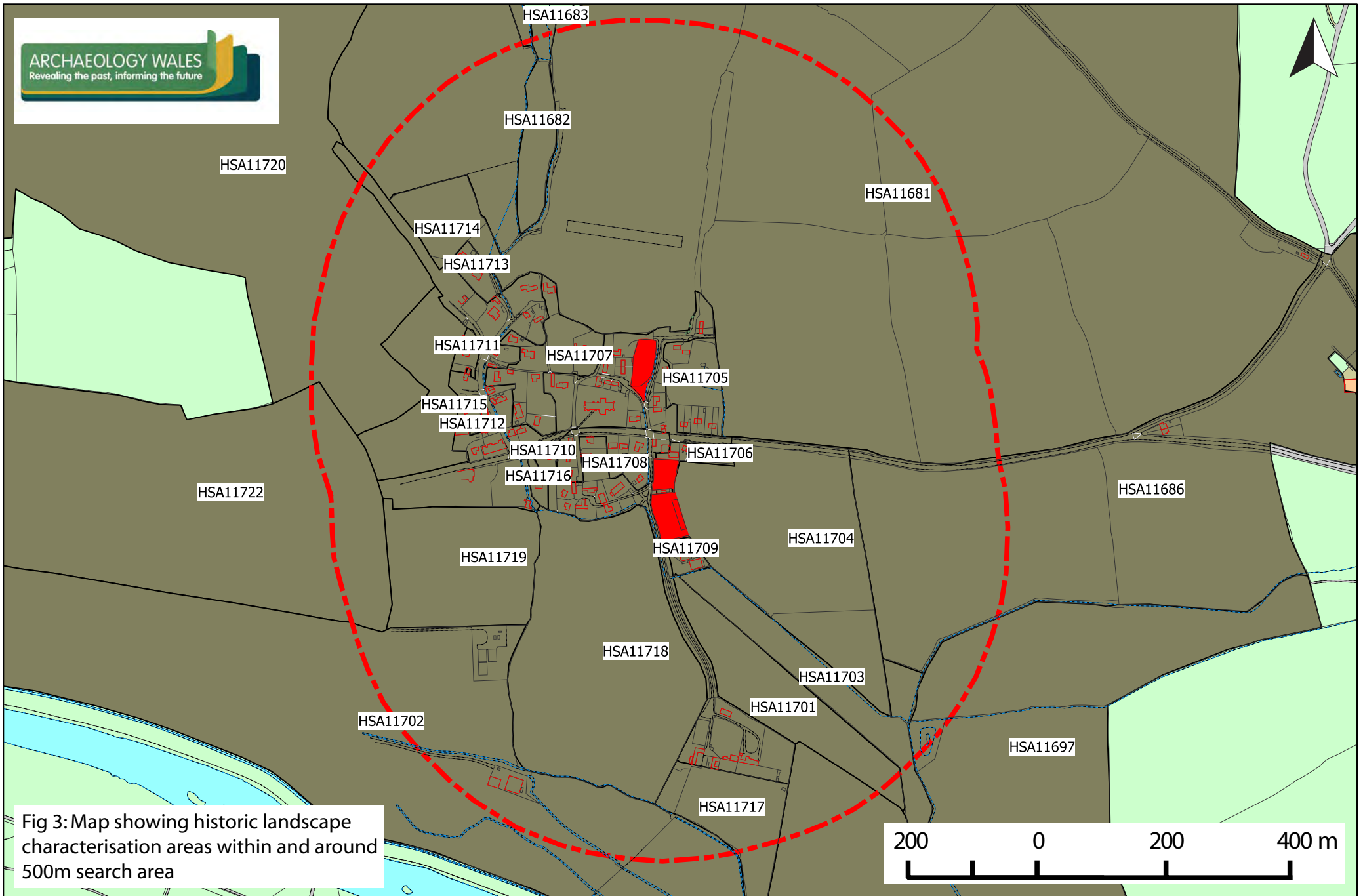


Fig 3: Map showing historic landscape characterisation areas within and around 500m search area



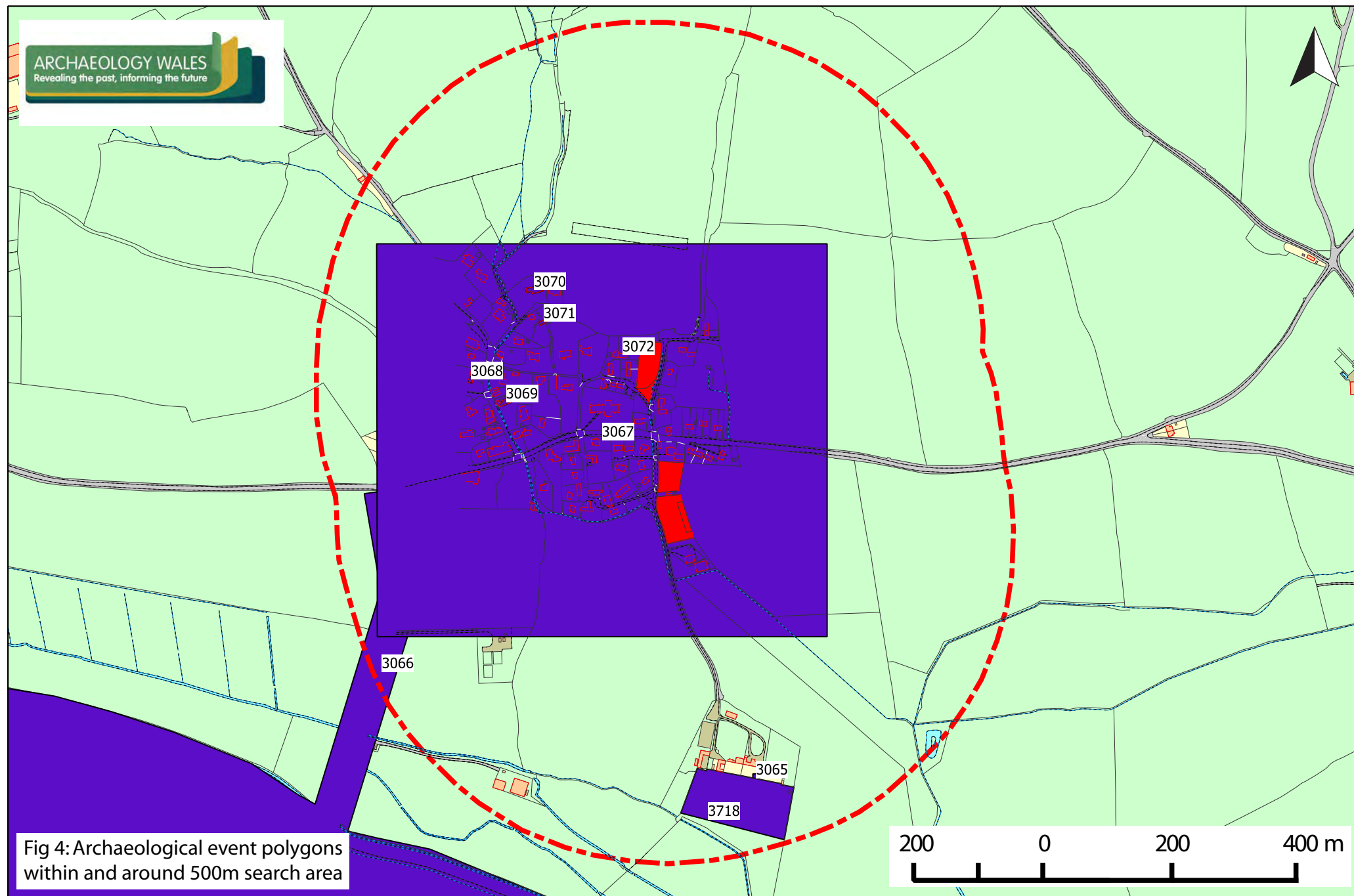


Fig 4: Archaeological event polygons within and around 500m search area

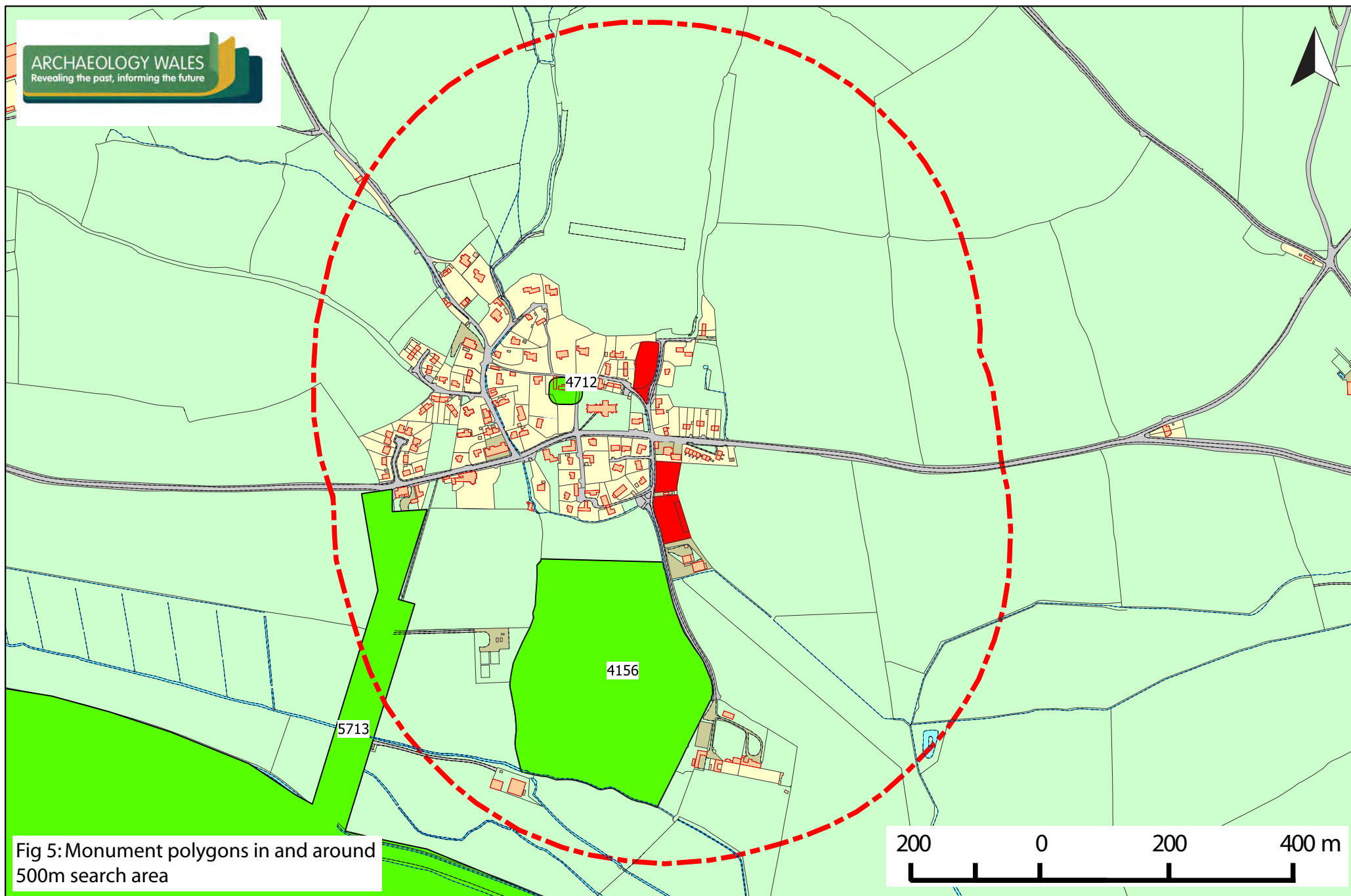


Fig 5: Monument polygons in and around 500m search area

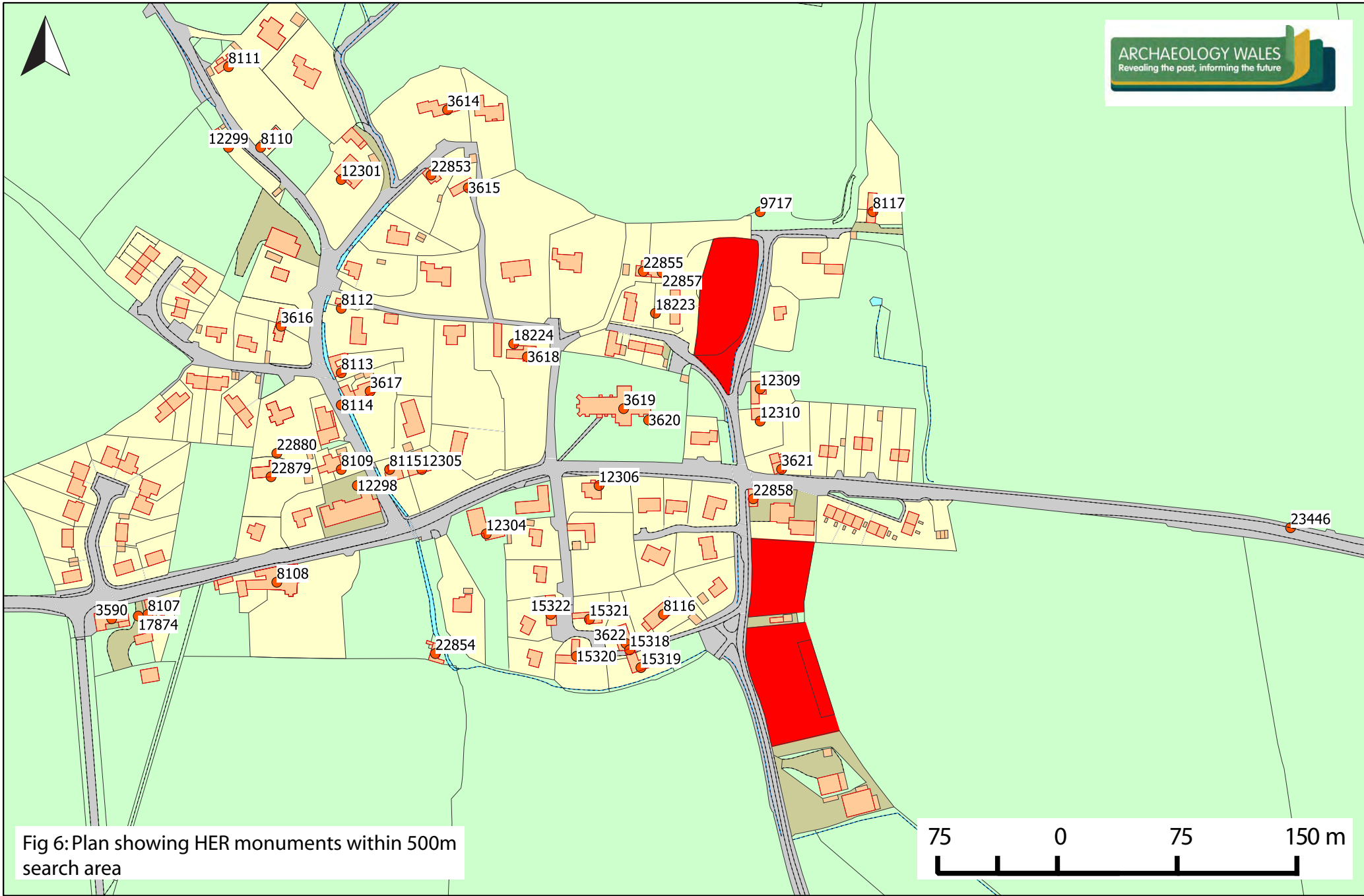


Fig 6: Plan showing HER monuments within 500m search area

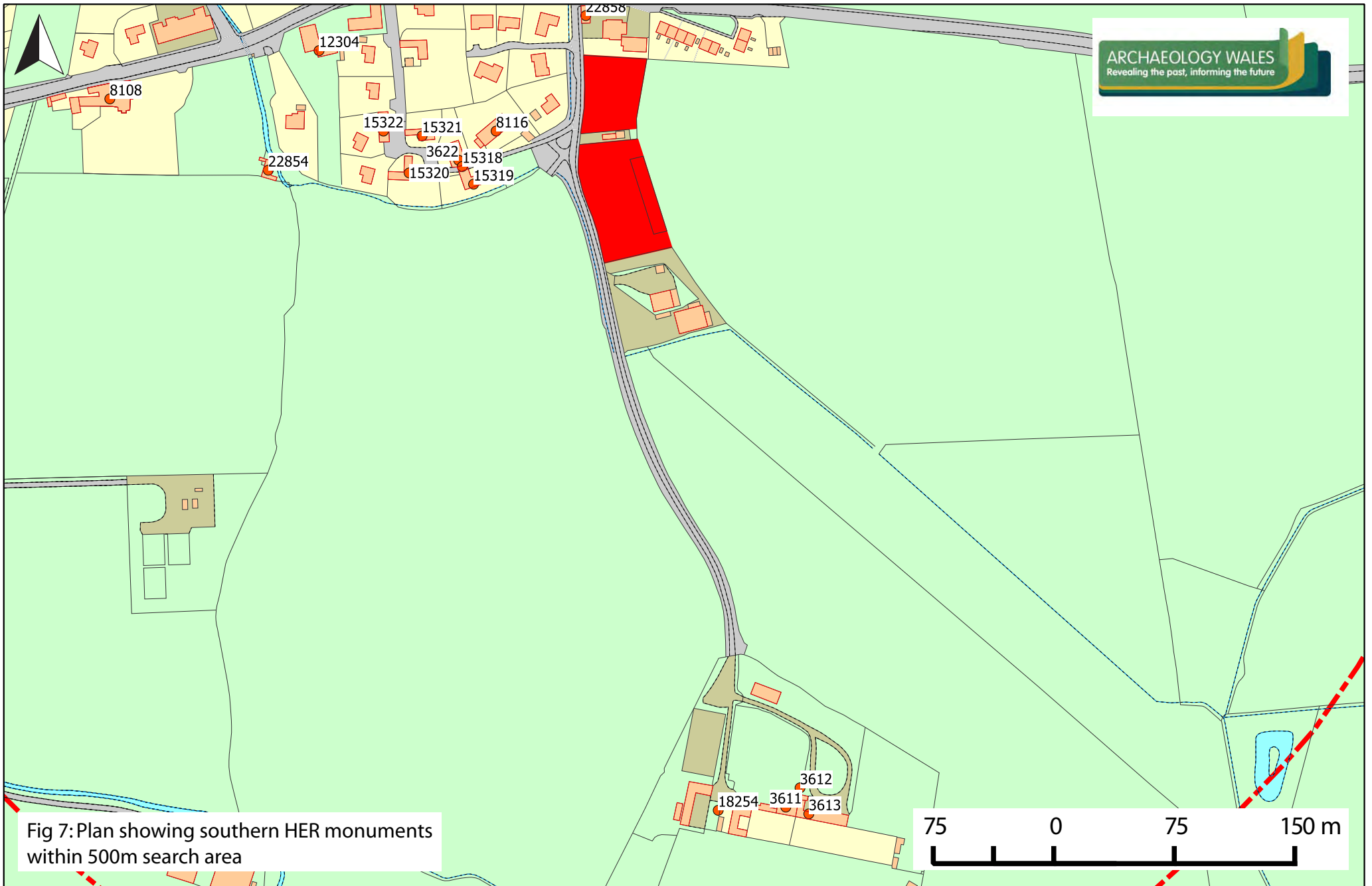


Fig 7: Plan showing southern HER monuments within 500m search area



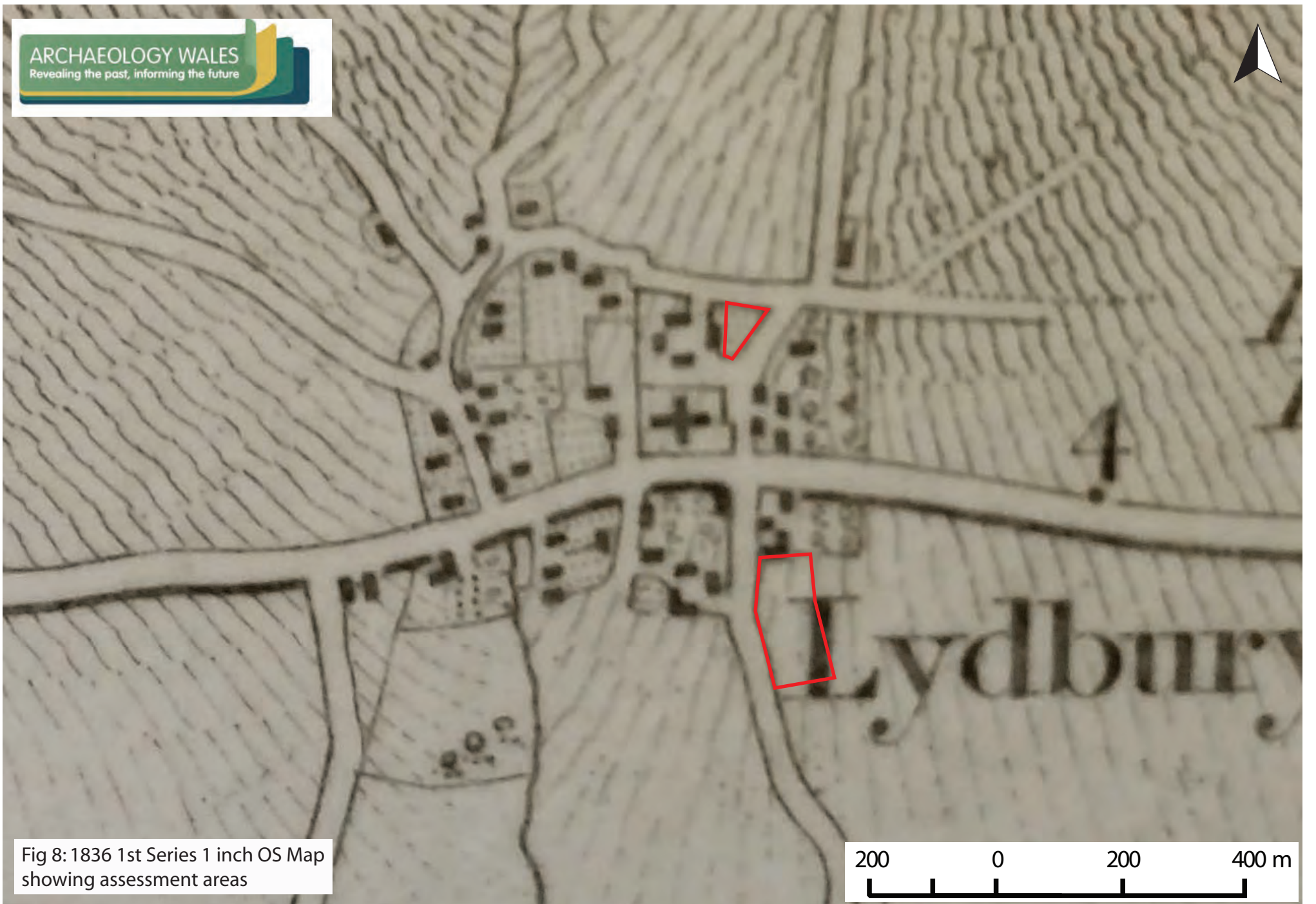


Fig 8: 1836 1st Series 1 inch OS Map showing assessment areas

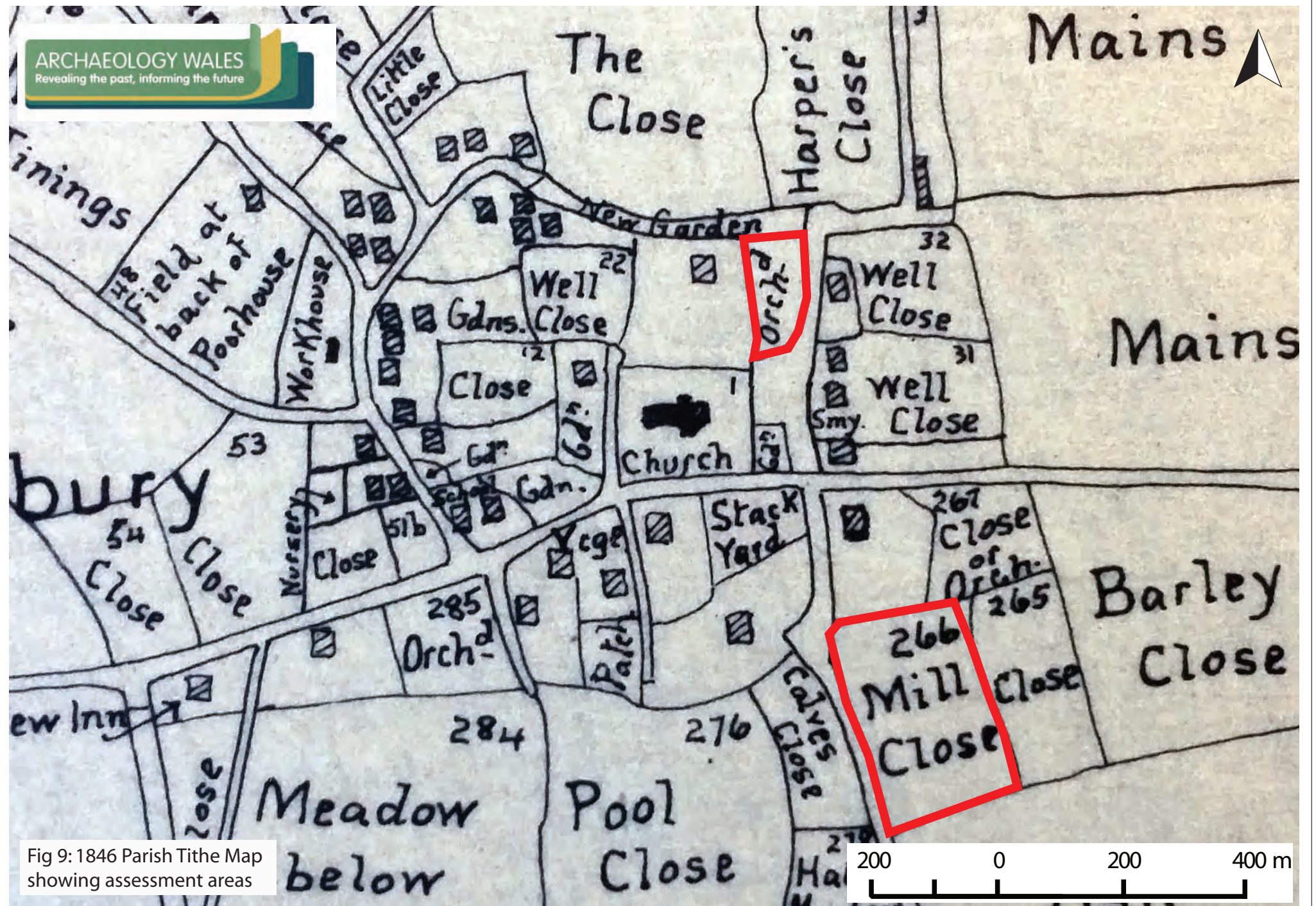


Fig 9: 1846 Parish Tithe Map showing assessment areas



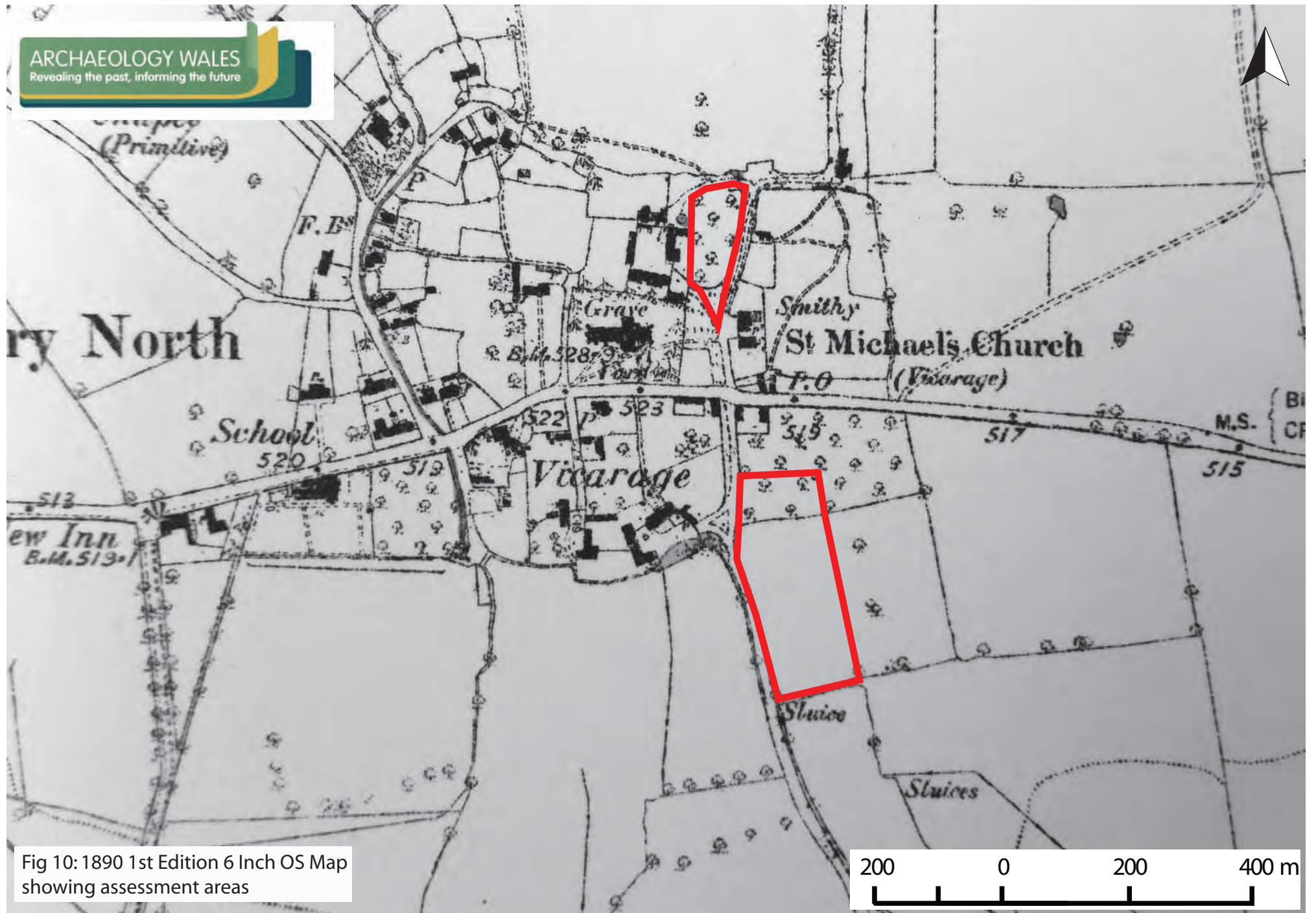


Fig 10: 1890 1st Edition 6 Inch OS Map showing assessment areas



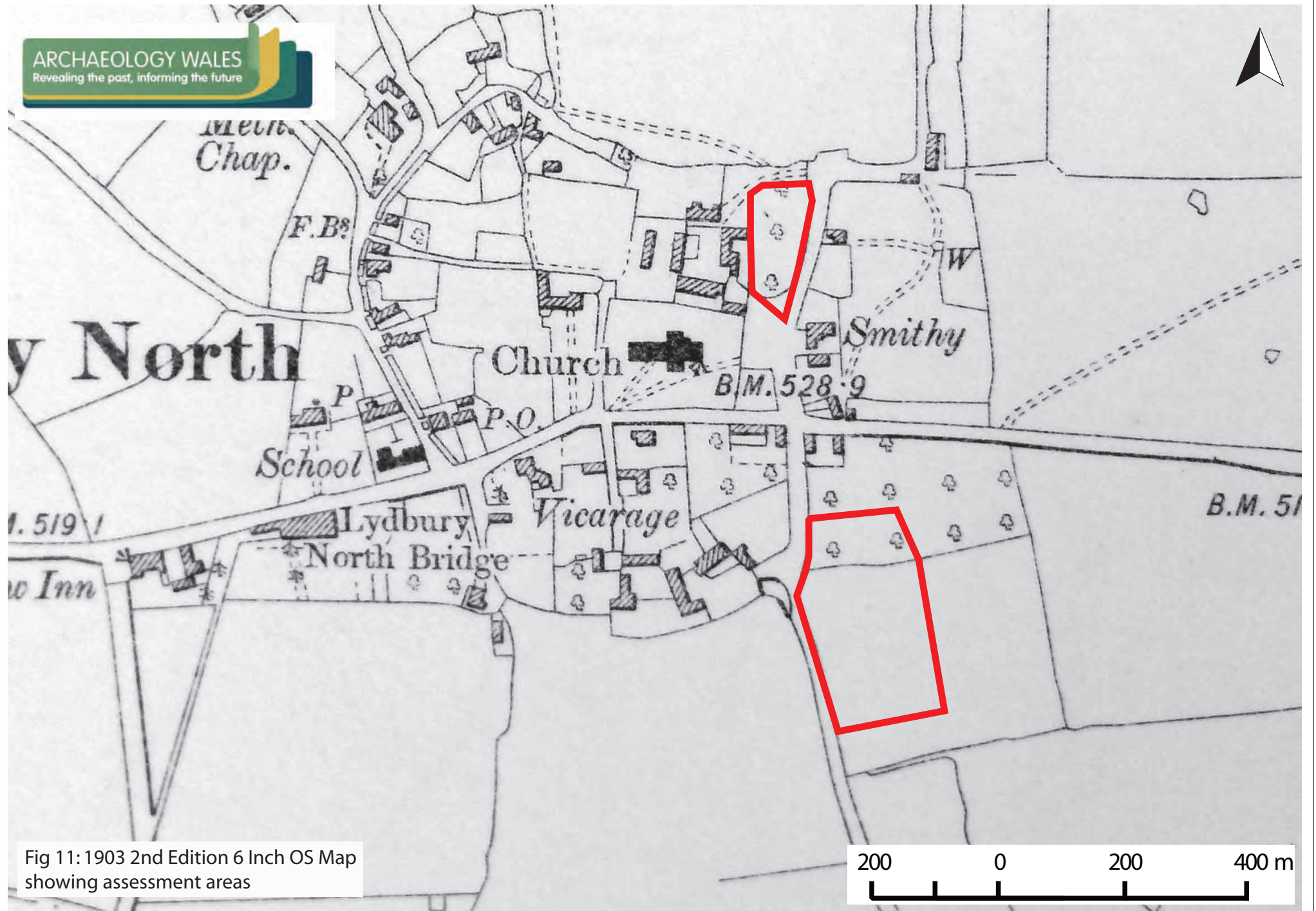


Fig 11: 1903 2nd Edition 6 Inch OS Map showing assessment areas



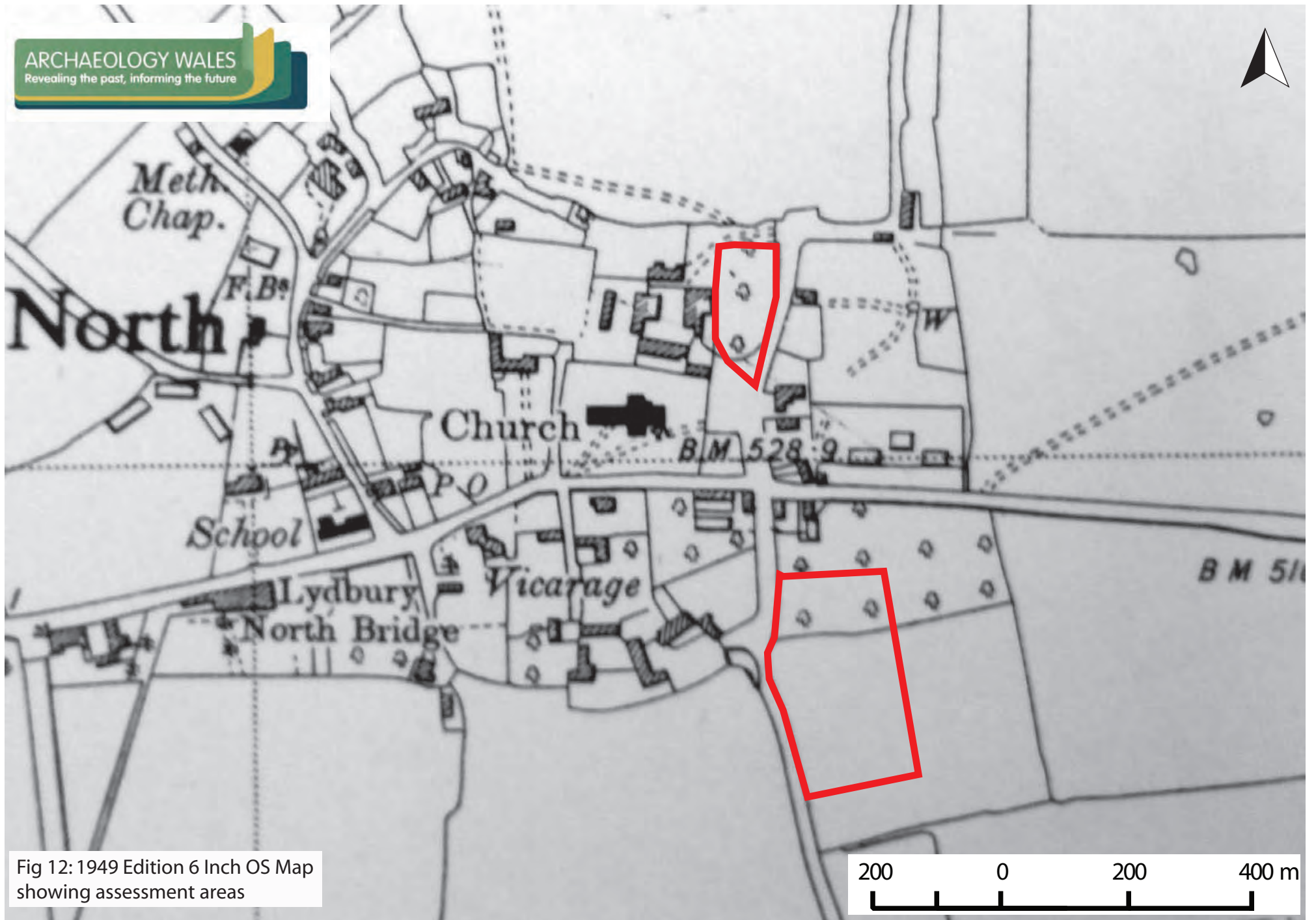


Fig 12: 1949 Edition 6 Inch OS Map showing assessment areas

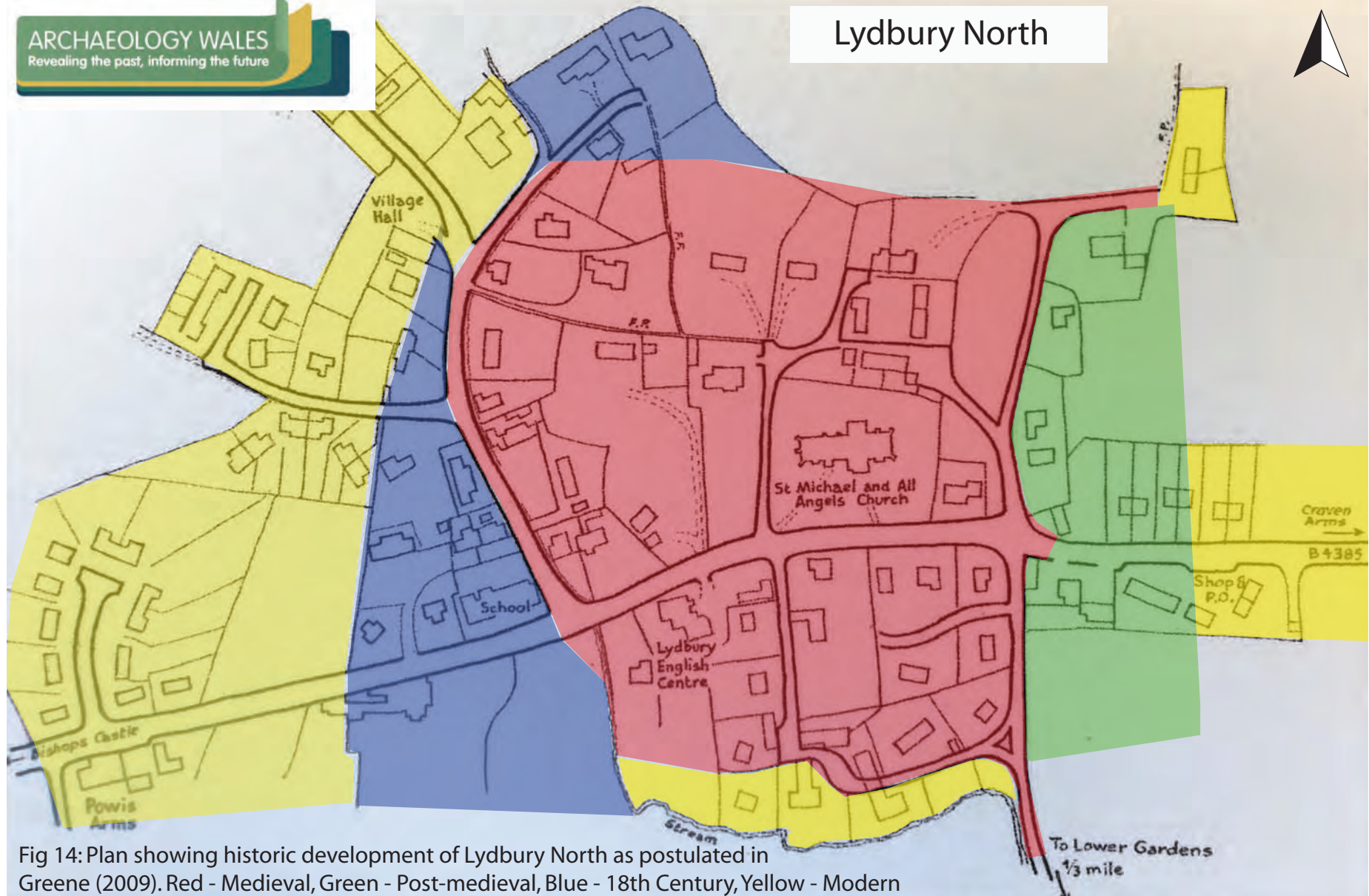


Fig 14: Plan showing historic development of Lydbury North as postulated in Greene (2009). Red - Medieval, Green - Post-medieval, Blue - 18th Century, Yellow - Modern

Geophysical survey carried out on two former formal garden sites near Lydbury North, Shropshire. Resistivity surveys and detailed magnetic surveys were carried out at both sites. The total survey area of 3600m<sup>2</sup> was split equally into two and covered agricultural land. Interpreting anomalies in both sites was made difficult due to the small survey area. The resistance data at Lower Gardens defines anomalies to a higher degree than the weak responses seen in the magnetic data. Based on this it is suggested that the electrical resistance technique was most effective at Lower Gardens. At Walcot however, the magnetic survey provided clearer results. <1>

**Summary:** Gardens, arboretum and deer park, associated with a country house (PRN 13644) rebuilt in 1764 for Lord Clive of India. The landscaping is principally a late 18th and very early 19th century reworking of a 17th one. Protected as a Grade II EH Registered Park or Garden.

**Description:** Formerly on the SMR as PRN 00534. A very extensive deer park existed at Walcot in 1813

The modern Walcot park is delineated on OS 6in map of 1903 centred at SO351 840. A linear cropmark is visible on RAF Aps between SO3450 8408 and SO3489 8401, and is mainly on line with the present parish boundaries of Clunbury and Lydbury North. There is also a cropmark between SO341839 and SO347841 <1.2>

A haye is mentioned in Domesday at Cheenpitune (Kempton at SO357 829 is a small hamlet adjacent to Walcot Park. <1.11>

Evaluated for MPP in 1990-1, as one of less than 10 Deer Parks.<2>

Gardens, arboretum and deer park, in all c. 479 ha, associated with country house rebuilt in 1764 for Lord Clive of India. The landscaping is principally a late 18C and very early 19C reworking of a 17C one.-

>

-> The main drive approaches from Lydbury North, which lies 1 km north of Walcot Hall. At first, as it crosses farmland, the drive is straight, and lined with Turkey oaks. It then enters the park, passes over the dam across Walcot pool, and turns south-east in to the straight, lime-lined approach (it or a predecessor established by c. 1730 along with avenues radiating east, and to a lesser extent west from the Hall) to the Hall's main, east, front, which has panoramic views out over Walcot pools to the Longmynd 5 km to the north-east. Other entries to the park are from the east: via a pair of early 19C lodges (both Listed Grade II: 1583/4/101-102) 1.5 km north of Kempton village where the tree lined drive continues east of the B 4385 as a way to Edgton; via drive with late 18 or early 19C lodge (Park Cottage, Listed Grade II: 1583/4/85) just north of Kempton; or via a drive with lodge on the west side of Kempton. New roads were made between Walcot and Kempton 1786-7.->

-> Walcot Hall (Listed Grade 11\*: 0948/5/133; 0948/9/133) was rebuilt after 1763 by Sir William Chambers for Lord Clive as a large, roughly U-plan, brick house. A ballroom was built off it to the west in the early 19C, the west end of which gave access to a long, curving hothouse (according to one contemporary 'the most spacious and costly I ever beheld') (also early 19C [certainly pre 1822] and demolished mid 20C) built against a brick wall (which does survive). That wall connects the hall with its large and impressive stables court (Listed Grade II [0948/5/134; 0948/9/134] after 1763 and probably by Chambers). Landscaping and planting work was done around the new house by William Emes c. 1774, although the precise nature and extent of that work is unclear.->

-> West and north of the stables, on rising ground, are the extensive kitchen gardens, enclosed by stone coped brick walls. These gardens are in two irregular compartments. One runs roughly west from the stables, and has a former gazebo attributed to

Chambers (Listed Grade 11\* [0948/9/138], ? An adaptation of a pigeon house) set in the wall (Listed Grade II [09485/139; 0949/9/139] for 70 m either side of gazebo) at its west end. The other, larger, compartment adjoins to the north. Most or all of the kitchen gardens were probably built 1703-6; a fountain, also built in that campaign, may be associated with a large cistern in the former compartment and a fountain basin in the latter. Terracing is visible in the compartments, although it is difficult to relate to their plan and may predate them. An 18C icehouse and vegetable store (Listed Grade II: 0949/5/135) is set into the northern angle of the more northerly compartment, while just west of the kitchen gardens, set in quite steeply shelving ground, are two triangular fishponds. Nearby, and passed by the approach drive, is a 19C game store (Listed Grade II: 0948/5/135) and a 17C dovecote (Listed Grade II: 0948/5/136).->

-> Among subscribers to Stephen Switzer's Practical Husbandman and Planter (1733-4) were John Walcot of Walcot and, in his own right, his gardener Thomas Dobbs. The gardens at Walcot at that time are shown on maps of c. 1700 and c. 1730. They ran away south from the Hall and comprised six compartments arranged 3 x 2 about a 200-metre long central axis, on which by c. 1730 a fountain had been constructed.->

-> The top of that terrace forms the eastern edge of the celebrated Walcot arboretum, developed by Clive's son Edward in the early 19C. That extends to c. 25 acres and includes a Douglas fir grown from one of the original seeds supplied by Douglas in 1827. Other trees include several other firs, and various spruces and pines. The west end of the arboretum is defined by a stone wall, a central entrance in which gives access to a holloway leading to fishponds set in permanent pasture beyond. A deep, stone-fronted ha-ha runs south-west from south of the main façade of the Hall, providing the southern boundary of both the site of the formal gardens and the arboretum. In 1994 a new, timber-framed house was under construction immediately outside the south-western corner of the arboretum.->

-> In the early 18th century the whole of the high ground west of the formal gardens, extending to within 400 m of Lower Down, was occupied by the deer park. The southern boundary of that park ran along the top of Pigeon house Bank, a small wooded valley running north east back towards the Hall. The two fishponds in the valley bottom were probably created from earlier ponds 1822 x1831. 100 m west of the western pool is the site of The Hermitage, an octagonal rustic summerhouse built 1802/13 and burnt down in the mid 20C.->

->Walcot Pool, the northern boundary of Walcot

Park, is c. 2 km long and c. 80m wide. The water is confined by means of a contour dam on its north side. Its modern extent was defined by 1822; reputedly French Napoleonic plans had been used in its creation although in 1799 Colt Hoare noted the 'piece of water' before the Hall and the map of c. 1730 marks a series of pools. There are boat houses by the dam and midway along the eastern half of the Pool, one in the latter position being present by 1822.->

Resistivity surveys and detailed magnetic surveys were carried out at both sites. The total survey area of 3600m<sup>2</sup> was split equally into two and covered agricultural land. Interpreting anomalies in both sites was made difficult due to the small survey area. The resistance data at Lower Gardens defines anomalies to a higher degree than the weak responses seen in the magnetic data. Based on this it is suggested that the electrical resistance technique was most effective at Lower Gardens. At Walcot however, the magnetic survey provided clearer results. <7>

In August 2006 the Monument Polygon was extended from the area defined by the EH Register of Parks and Gardens to cover the area of the park as indicated by the first edition OS County Series 1:10560 scale map.[<8>] <9>
