

**NOTICE OF PUBLIC PATH DIVERSION AND DEFINITIVE MAP
AND STATEMENT MODIFICATION ORDER
TOWN AND COUNTRY PLANNING ACT 1990, SECTION 257
WILDLIFE AND COUNTRYSIDE ACT 1981, SECTION 53(A)(2)
THE SHROPSHIRE COUNCIL (FOOTPATH 2 (PART) PARISH OF NORTON IN
HALES) PUBLIC PATH DIVERSION ORDER 2018.**

The above order was made on 25th January 2018. The effect of the order will be to divert The full width of that part of Footpath 2 leaving Chapel Lane at point A on the Order Map (GR 7006 3862) running in a general southerly direction on a natural surface to point B on the Order Map (GR 7006 3853). a total distance of approximately 92 metres onto a line running from Chapel Lane at point C on the Order Map at GR 7009 3860 in a general south westerly then southerly direction following the surfaced access road to join the line of FP 2 at point B on the Order Map at GR 7006 3853. A total distance of approximately 105 metres with a width of 1.8 metres throughout its length.

If the order is sent to the Secretary of State for the Environment, Food and Rural Affairs for confirmation any representations or objections which have not been withdrawn will be sent with the order.
